I. Bennett Capers is an associate professor of law at Hofstra Law School where he specializes in criminal law and procedure, race and the law, law and literature, and gender and the law. His articles have appeared in *Harvard Civil Rights-Civil Liberties Law Review*, *Yale Journal of Law and the Humanities*, *Indiana Law Journal*, *Hofstra Law Review*, *Michigan Journal of Race and the Law*, *New York University Review of Law and Social Change*, *California Law Review*, *Howard Law Journal*, and *Columbia Law Review*. He is currently a visiting professor at Fordham Law School.

Charlton Copeland is an associate professor at the University of Miami Law School. His teaching and research interests include administrative law, federalism, civil procedure, constitutional law, law and religion, and race and the law. His publications include “Private Pathologies and Public Policies: Race, Class and the Failure of Child Welfare” in *Yale Law & Policy Review*. He is currently working on several articles, including “Federalism Beyond Power: Judicial Mediation of the Federal-State Relationship,” “Anti-Constitutional: The Legitimacy and Limits of Judicial Invalidation of Constitutional Amendments,” and “Then There Were Two: The Supreme Court’s Section Five Jurisprudence and the Political Isolation of Race and Gender.”

Matthew L. M. Fletcher is an associate professor at Michigan State University College of Law and director of the Indigenous Law and Policy Center, sits as an appellate judge for the Pokagon Band of Potawatomi Indians and the Hoopa Valley Tribe, and is a consultant to the Seneca Nation of Indians Court of Appeals. He is an enrolled member of the Grand Traverse Band of Ottawa and Chippewa Indians located in Peshawbestown, Michigan. He will coauthor the sixth edition of *Cases on Federal Indian Law* (Thomson West) with David Getches, Charles Wilkinson, and Robert Williams. He recently published *American Indian Education: Counternarratives in Racism, Struggle, and the Law* (Routledge). His articles have appeared in the *Harvard Journal on Legislation*, *Houston Law Review*, *Hastings Law Journal*, and *Tulane Law Review*, and he is currently writing a book on the history of the Grand Traverse Band. He has worked as a staff attorney for the Pascua Yaqui Tribe, the Hoopa Valley Tribe, the Suquamish Tribe, and the Grand Traverse Band, and he has litigated over twenty tribal court cases. He is married to Wenona Singel and they have a son named Owen.

Akilah Folami is an associate professor at Hofstra University School of Law. She has written on media consolidation in broadcast radio and its effect on music and American youth, particularly in hip-hop culture, and has testified before the Federal Communications Commission regarding her findings. Professor Folami’s scholarly interests include the intersection of communications law, popular culture, and the regulation of speech. Prior to joining Hofstra, she clerked for

Honorable Constance Baker Motley of the U.S. District Court for the Southern District of New York and practiced in intellectual property and other Internet-related issues at two major New York law firms.

William Gleason is an associate professor of English at Princeton University, where he specializes in nineteenth and twentieth-century American literature, American popular writing, and American social and cultural history. He is the author of *The Leisure Ethic: Work and Play in American Literature, 1840–1940* (1999) as well as essays on such figures as Frederick Douglass, Charles Chesnutt, Edith Wharton, Edgar Rice Burroughs, Thomas Pynchon, and Louise Erdrich. “It Falls to You” is his third essay on the work of Charles Johnson. Gleason is currently completing a study of race, architecture, and American literature.

K. J. Greene is a native New Yorker, a graduate of the Yale Law School, and a tenured law professor on the faculty of Thomas Jefferson School of Law in San Diego, California, where he teaches contracts, intellectual property, music law, and entertainment law. He was recently selected by peers in the San Diego intellectual property bar as one of the top ten intellectual property (IP) attorneys in San Diego County, and he has developed a national reputation as an IP scholar and a leading expert on the subject of African American music and copyright law. As an attorney in leading New York law firms, Greene represented clients such as Time-Warner/HBO, film producer Spike Lee, pop singer Bobby Brown, television star Geraldo Rivera, and the ground-breaking rap group Public Enemy. Before attending law school, he served with honor in the U.S. Marine Corps.

Sharon M. Harris is a professor of English at the University of Connecticut, Storrs and the author or editor of ten books, including critical studies such as *Executing Race: Early American Women’s Narratives of Race, Class, and Society* (2005); collections of critical essays, including *Periodical Literature of Eighteenth-Century America* (2005); and scholarly editions, including *Writing Cultural Autobiography: Rebecca Harding Davis’s Autobiographical Narratives*. She is also a series editor for the University of Nebraska Press’s Legacies of Nineteenth-Century U.S. Women’s Writings. In addition, Professor Harris was a founding officer of the Society of Early Americanists (1992–99) and founding president of the Society for the Study of American Women Writers (1998–2003). In 2005 and 2007, respectively, Professor Harris was awarded a National Endowment of the Humanities Fellowship and a University of Connecticut Humanities Institute Fellowship. Professor Harris currently has several projects in press: *Dr. Mary Walker: An American Radical* (Rutgers), *The Selected Letters of Mercy Otis Warren* (Georgia), *A Feminist Reader: From Sappho to the Gorilla Grrrls* (3 volumes, Cambridge), and *Rebecca Harding Davis: The Civil War Years* (Georgia).

Karla F. C. Holloway is James B. Duke Professor of English and professor of law at Duke University. Her research and teaching focus on African American studies, biocultural studies, ethics, and law. Her board memberships, including the Greenwall Foundation’s Board in Bioethics; Princeton University’s Council for the Program in the Study of Women and Gender; and her faculty affiliation with the Trent Center for Bioethics, Medical Humanities, and the History of Medicine reflect her scholarly interests. Since the publication of her book, *Passed On—African*

American Mourning Stories (2002), she has led national discussions urging end-of-life care conversations in African American communities. Her public essays on death and dying, featured on National Public Radio, include the well-received "Giving a Name to the Pain of Losing a Child." Professor Holloway's recent essays indicate her scholarship's interdisciplinarity and include "Cruel Enough to Stop the Blood: Global Feminisms and the U.S. Body Politic, or: 'They Done Taken My Blues and Gone'" (*Meridians* 6, no. 5); the controversial "Accidental Communities: Race, Emergency Medicine and the Problem of Polyheme" in *The American Journal of Bioethics*; and "Private Bodies/Public Texts: Literature, Science, and States of Surveillance" in *Literature and Medicine* (2007). Her current work-in-progress, a book on bioethics and law with a focus on race and gender, is under contract with Johns Hopkins University Press. She is the recipient of national awards and foundation fellowships, most recently the Rockefeller Foundation's Bellagio Residency Fellowship and the Sheila Biddle Ford Foundation fellowship at Harvard University's Du Bois Institute.

Gerald Horne holds the John J. and Rebecca Moores Chair of History and African American Studies at the University of Houston. His research has addressed issues of race in a variety of relations involving labor, politics, civil rights, and war. He is the author of more than seventeen books and one hundred scholarly articles and reviews. His recent publications include *The End of Empires: African-Americans and India* (Temple, 2008), *The Deepest South: The U.S., Brazil and the African Slave Trade* (New York University Press, 2007), *The White Pacific: U.S. Imperialism and Black Slavery in the South Seas after the Civil War* (Hawaii, 2007), *Cold War in a Hot Zone: The U.S. Confronts Labor and Independence Struggles in the British West Indies* (Temple, 2007), *Black & Brown: Africans and the Mexican Revolution, 1910–1920* (New York University Press, 2005), *Race War! White Supremacy & the Japanese Attack on the British Empire* (New York University Press, 2003), *Powell v. Alabama: The Scottsboro Boys and American Justice* (Franklin Watts, 1997), and others. His forthcoming books are *Mau Mau in Harlem? The U.S. and the Liberation of Kenya* (Palgrave, 2009), *Reds in Paradise? Radical Labor and Racism in the Making of Modern Hawaii* (Hawaii, 2009), and *Negroes with Guns? African-Americans and the British Empire Confront the U.S. Before the Civil War*.

Loverlie King is an associate professor of English, affiliate faculty in Women's Studies, and director of the Africana Research Center at Penn State-University Park. She specializes in African American literary history. Her publications include *Race, Theft, and Ethics: Property Matters in African Literature* (2007); *The Cambridge Introduction to Zora Neale Hurston* (2008); and two coedited volumes: *James Baldwin and Toni Morrison: Comparative Critical and Theoretical Essays* (2006), and *New Essays on the African American Novel: from Hurston and Ellison to Morrison and Whitehead* (2008).

D. Quentin Miller is an associate professor of English at Suffolk University and has published or edited three books: *Re-Viewing James Baldwin: Things Not Seen, John Updike and the Cold War: Drawing the Iron Curtain*, and *Prose and Cons: New Essays on U.S. Prison Literature*. He is editor of the composition textbook *The Generation of Ideas*, the literature textbook *Connections*, and one of the coeditors of the *Heath Anthology of American Literature*. His essays have appeared in such journals

as *American Literature*, *Legacy*, *Forum for Modern Language Studies*, *English Language Notes*, and *American Literary Realism*. He is developing a book-length study of James Baldwin.

Richard Schur is an associate professor and director of Interdisciplinary Studies at Drury University. His articles and essays on African American literature, hip-hop studies, African American art, critical race theory, and intellectual property law have appeared in journals such as *Contemporary Literature*, *American Studies*, *African American Review*, *Biography*, and *Law & Inequality*, and in several edited collections. He is the author of *Parodies of Ownership: Hip-Hop Aesthetics and Intellectual Property Law* (2009).

Rebecca Wanzo is an associate professor of English and Women's Studies at Ohio State University. Her book, *The Suffering Will Not Be Televised: African American Women and Sentimental Political Storytelling* (SUNY) examines how African American women make claims about their pain legible in the political logic of storytelling about suffering in the United States. Her research interests include African American literature and culture, cultural studies, critical race theory, feminist theory, graphic storytelling, and theories of affect.

Rochelle Raineri Zuck is an assistant professor of English at the University of Minnesota-Duluth. Her research and teaching interests include eighteenth- and nineteenth-century American literatures, African American and American Indian literatures, and print culture. She has published an essay entitled "Cultivation, Commerce, and Cupidity: Late-Jacksonian Virtue in James Fenimore Cooper's *The Crater*" in *Literature in the Early American Republic*. She is currently working on her first book project, tentatively titled *Imagined Citizens: Ethnic Nationalisms and Crises of Culture, 1816–1856*.
