

Notes on Contributors

David Cannadine is Director of the Institute for Historical Research at the University of London, having returned to England from a Chair in History at Columbia University. His many books include *The Pleasures of the Past*, *History in our Time*, *The Rise and Fall of Class in Britain* and *Ornamentalism: How the British Saw their Empire*. He edits the journals *Historical Research* and *Reviews in History*.

Richard J. Evans is Professor of Modern History at the University of Cambridge, and fellow of Gonville and Caius College. He is the author of ten books including *In Defence of History* and, most recently, a controversial study of the Irving Trial, *Telling Lies about Hitler*.

Paul Cartledge, Professor of Ancient History at the University of Cambridge, and Fellow of Clare College, is the author of three books on Sparta and one on Aristophanes, and has edited three collections of essays on Greek and Athenian history. His most recent books are *The Greeks*, *Democritus and Atomistic Politics*, and *The Greeks: Crucible of Civilization*, a companion volume to a major US television series. He has edited the *Cambridge Illustrated History of Ancient Greece*, and co-edits the series 'Key Themes in Ancient History' and 'Classical Inter/Faces'.

Annabel Brett is a Fellow of Gonville and Caius College, Cambridge. Her publications include *Liberty, Right and Nature* and an edited collection of essays *On the Power of Emperors and Popes*.

Linda Colley is Leverhulme Research Professor in History at the London School of Economics and Political Science. Formerly Richard M. Colgate Professor of History at Yale University, she has also taught at the University of Cambridge. Among her many publications, the bestselling *Britons: Forging a Nation, 1707–1837* won the Wolfson Prize.

Susan Pedersen is Professor of History at Harvard University. Her publications include *Family Policy and the Origins of the Welfare State: Britain and France, 1914–45*, and *After the Victorians: Private Conscience and Public Duty in Modern Britain* edited with Peter Mandler.

Olwen Hufton is Leverhulme Research Professor at the University of Oxford and a fellow of Merton College. She is also a Fellow of the British Academy and the Royal Historical Society. Her many publications include *Europe: Privilege and Protest 1730–1789*, *Women and the Limits of Citizenship in the French Revolution* and *The Prospect Before Her: A History of Women in Western Europe, I: 1500–1800*.

Miri Rubin is Professor of European History and Director of Research at Queen Mary, University of London. She has previously held academic positions at Cambridge, Princeton and Oxford. Her publications include *Corpus Christi: The Eucharist in Late Medieval Culture* and *Gentile Tales*, and she co-edited *Framing Medieval Bodies*. She is currently writing the late medieval volume of *The New Penguin History of Britain*.

Alice Kessler Harris is Professor of History at Columbia University. She has published extensively on women's labour history, in which the latest of her four published books is *In Pursuit of Equity: How Gender Shaped American Economic Citizenship*. She is co-editor of *Protecting Women: Labor Legislation in Europe, Australia, and the United States, 1880–1920* (1995), and *U.S. History as Women's History* (1995).

Felipe Fernández-Armesto is Professor of History at Queen Mary, University of London. His many books include *Civilizations: Culture, Ambition and the Transformation of Nature*, *Millennium: A History of the last Thousand Years*, and *Truth: A History and a Guide for the Perplexed*.
