

Notes on Contributors

David Barker is Professor and Head of the Department of Geography & Geology at the University of the West Indies, Mona campus, in Kingston, Jamaica, where he has been a Geography Lecturer since 1980. He is a coauthor of the tertiary-level textbook *Contemporary Caribbean* (2004), and a coeditor in the book series: *Environment and Development in the Caribbean: Geographical Perspectives* (1995), *Resource Sustainability and Caribbean Development* (1998), and *Resources, Planning and Environmental Management in a Changing Caribbean* (2003). Additionally, he is cofounder and editor of the regional journal *Caribbean Geography*. Dr. Barker's main research interest focuses on small-scale agriculture and indigenous knowledge, and hillside farming and environmental degradation in Jamaica.

Jean Besson, a Jamaican, is Reader in Anthropology at Goldsmiths College, University of London. Dr. Besson has also taught at the universities of Edinburgh and Aberdeen and held visiting appointments at the University of the West Indies, Mona, and the Johns Hopkins University. She has carried out research in Jamaica and the Eastern Caribbean. Her publications include *Martha Brae's Two Histories: European Expansion and Caribbean Culture-Building in Jamaica* (University of North Carolina Press, 2002), *Caribbean Narratives of Belonging: Fields of Relations, Sites of Identity* (coedited with Karen Fog Olwig, Macmillan, 2005), and *Land and Development in the Caribbean* (coedited with Janet Momsen, Macmillan, 1987).

Margaret Byron is a Lecturer in the Department of Geography, King's College, London. She has a DPhil in Geography from Oxford. Her research interests include labor migration, particularly postwar Caribbean migration to Europe and the impact of return migration to the region in recent decades. She is currently working on Caribbean communities in urban Britain and France, focusing on gender, generation, and the employment and housing histories of these multigenerational communities. Her publications include *Post War Caribbean Migration to Britain: The Unfinished Cycle* (Avebury, 1994) and, with Stephanie Condon, *Migration in Comparative Perspective: Caribbean Communities in Britain and France*, (Routledge, 2007).

Christine Chivallon is an anthropologist and geographer, employed by the CNRS (National Center of Scientific Research) in France. Dr. Chivallon's

research has focused on space and identity, mainly in Caribbean societies and through Caribbean migration also in Europe, including research on the memory of slavery. Among her major recent works are *La diaspora noire des Amériques, expériences et théories à partir de la Caraïbe* (Paris, CNRS Éditions, 2004) and “Beyond Gilroy’s Black Atlantic: The Experience of the African Diaspora,” *Diaspora. A Journal of Transnational Studies* 11, no. 3 (2002): 359–382.

Colin Clarke is Emeritus Professor of Geography at Oxford University and an Emeritus Fellow of Jesus College. He has taught at the universities of Liverpool and Toronto and has carried out many research projects in Mexico and the Caribbean. His principal research interests are in race, ethnicity and class, urban and rural social structures and their spatial expression, and peasant transformation. Professor Clarke’s most recent publications include *Class, Community and Ethnicity in Southern Mexico: Oaxaca’s Peasantries* (Oxford University Press, 2000), *Kingston, Jamaica: Urban Development and Social Change, 1692–2002* (Ian Randle Publishers, 2006), and *Decolonizing the Colonial City: Urbanization and Stratification in Kingston, Jamaica* (Oxford University Press, 2006).

Lawrence S. Grossman is a Professor in the Department of Geography at Virginia Tech. He has been conducting research in the Caribbean since the late 1980s and is the author of *The Political Ecology of Bananas: Contract Farming, Peasants, and Agrarian Change in the Eastern Caribbean* (University of North Carolina Press, 1998). Dr. Grossman is currently conducting archival research on colonial environmental discourses and policies related to deforestation and soil erosion in the British Caribbean from the late 1800s to 1950.

Ellen-Rose Kambel obtained a law degree and a PhD in Social Sciences from the University of Leiden, the Netherlands. For the past 10 years, she has worked with indigenous communities in Suriname and has co-authored several books and reports on human rights, development, and gender issues. She currently works as an independent human rights trainer and researcher.

David Lowenthal is an Emeritus Professor of Geography at University College, London. He taught history at U(C) WI in Jamaica in 1956–1957 and was research associate at ISER, and then extramural consultant to the vice chancellor. The Institute of Race Relations (London) commissioned his *West Indian Societies* (Oxford University Press, 1972). With Colin Clarke he served as Barbuda advocate at the Antigua-Barbuda Independence Conference (London, 1980).

Donald Macleod is a Lecturer and Head of Tourism and Heritage at the University of Glasgow and has a doctorate in social anthropology from the University of Oxford. He has undertaken field research in the Canary Islands, the Caribbean, and Scotland, and his interests include sustainable development, globalization, cultural change, tourism, heritage, and identity. His publications

include the books *Tourism, Globalization and Cultural Change* (Channel View Publications, 2004), *Niche Tourism in Question* (Glasgow University Crichton Publications, 2003), and *Tourists and Tourism* (Berg, 1997).

Learie A. Miller worked as Director for more than a decade with the Natural Resources Conservation Authority/National Environment and Planning Agency in Jamaica. He was also an adjunct faculty member of the University of the West Indies Geography Department for several years. He has a MSc degree from the University of Toronto in Environmental Management and Geomorphology and a joint Ryerson University/University of Toronto Masters in Spatial Analysis (MSA). He now works as a Resources Planner with the Kawartha Region Conservation Authority in Ontario, Canada.

Beth Mills has a Master's degree from the University of New Mexico and a PhD in Geography from the University of California, Davis. She has carried out fieldwork in the Caribbean for over 20 years, and her research focuses on questions of land use and migration in Carriacou, Grenada. Dr. Mills' broader research interests include the connection between culture and land use, transnational migration, and community development. She lives in Santa Fe, New Mexico, with her two children, where she works with local government as a land-use planner and as a part-time faculty member in the School of Architecture and Planning at the University of New Mexico.

Janet Momsen is Professor of Geography in the Department of Human and Community Development at the University of California, Davis. She has taught in Canada, the United Kingdom, Costa Rica, and Brazil. Her research interests include gender and development, rural development, agrobiodiversity, and tourism in the Caribbean, Mexico, Eastern Europe, and Bangladesh. Dr. Momsen's publications on the Caribbean include *Land and Development in the Caribbean* (coedited with Jean Besson, Macmillan, 1987), *Women and Change in the Caribbean* (James Currey and Ian Randle, 1993), and *Environmental Planning in the Caribbean* (with Jonathan Pugh, Ashgate, 2006).

Debbie A. Niemeier is a Professor of Civil and Environmental Engineering at the University of California, Davis. She is interested in issues of transportation and accessibility and is currently Director of the John Muir Institute of the Environment at UC, Davis.

Jonathan Pugh is the Academic Fellow in Territorial Governance at the University of Newcastle upon Tyne. He has a PhD in Geography from the University of London. His major interests include participatory and environmental planning in the Caribbean and the theoretical relationship between space, time, and the political. He is the coeditor, with Janet Momsen of *Environmental Planning in the Caribbean* (Ashgate, 2006) and with Robert Potter of *Participatory Planning in the Caribbean* (Ashgate, 2004).

Bonham C. Richardson is an Emeritus Professor having retired from the Geography Department at Virginia Tech in 2003. He has been doing fieldwork

and archival research in the Caribbean since 1967 in Guyana, Trinidad, Carriacou, St. Kitts-Nevis, and Barbados. His most recent book is *Igniting the Caribbean's Past* (University of North Carolina Press, 2004).

Mimi Sheller is a Visiting Associate Professor in the Department of Sociology and Anthropology at Swarthmore College, USA, and Senior Research Fellow in the Centre for Mobilities Research at Lancaster University, UK. She is coeditor of the journal *Mobilities* and author of *Consuming the Caribbean* (Routledge, 2003) *Democracy after Slavery: Black Publics and Peasant Radicalism in Haiti and Jamaica* (Macmillan Caribbean, 2000), and coeditor of *Uprootings/Regroundings* (Berg, 2003), *Tourism Mobilities* (Routledge, 2004), and *Mobile Technologies of the City* (Routledge, 2006). Dr. Sheller's Caribbean research has focused on the history of Jamaica and Haiti.

Jonathan Skinner is a Lecturer in Social Anthropology at the Queen's University of Belfast. He has carried out long-term fieldwork on the island of Montserrat where he investigates colonial and postcolonial relations as expressed through calypso, poetry, development work, and political debate published as *Before the Volcano: Reverberations of Identity on Montserrat* (Arawak Publications, 2004). He also has interests in tourism and dance, edits the journal *Anthropology in Action*, and serves as EASA Publications Officer.

Balfour Spence is a Jamaican with BA and MPhil degrees from the University of the West Indies and a PhD from the University of Manitoba, Canada. He is a Lecturer in Geography at the University of the West Indies, Mona, Jamaica. His research focuses on agriculture and tourism in Jamaica.

J. David Stanfield has degrees in Mathematics (Ohio State), International Relations and Organization (American University), and Communication (Michigan State). He worked at the Land Tenure Center at the University of Wisconsin until retirement in 2004 and with the Terra Institute at Mt. Horeb, Wisconsin, from its founding in 1974 until the present day. His research has attempted to deal intellectually and practically with "land tenure" issues mainly in such places as Wisconsin, Chile, Honduras, Nicaragua, Dominican Republic, Ecuador, Syria, Egypt, the Caribbean, Albania, Georgia, Kyrgyzstan, and Afghanistan.

Glenroy Taitt is a Trinidadian and holds a PhD in History from Sussex University. He is Librarian III/Special Collections Librarian in the Main Library at the University of the West Indies, St. Augustine, Trinidad. She is the James Seivright Moss-Solomon (Senior) Professor of Environmental Management at the University of the West Indies, Mona, Jamaica. Professor Thomas-Hope is a Jamaican and the author of *Explanation in Caribbean*

Migration (Macmillan Caribbean, 1992) and editor of *Solid Waste Management: Critical Issues for Developing Countries* (Canoe Press, 1998).

Rebecca Torres is an Assistant Professor in the Department of Geography at East Carolina University, Greenville, North Carolina. She has a Master's degree in International Agricultural Development and a PhD in Geography from the University of California, Davis. Dr. Torres has published widely on rural development, agricultural transformation, tourism, and migration and has carried out field research in Cuba, Mexico, Peru, and the U.S. South.

A. A. Wijetunga has wide professional and applied experience in land policy formulation, institutional and legal reform. He has worked as an independent Consultant for the World Bank, the Inter-American Development Bank, and USAID in Asia and the Caribbean.
