Current research pursuits include long-term issues in networked systems security for the financial services industry; architecture (control and coordination algorithm) for homeland security to enable the first responders to continue their mission in the event of terrorism by highly sophisticated terrorists; network-centric systems design language (NCSDDL) and execution environment to facilitate the modeling, testing, and performance analysis of any networked information technology system; next generation secure ATM network design; determining network operating point for operational networks; novel network architecture to resist lightning-fast intrusions; identifying requirements of future network design from the perspective of law enforcement; new forms of cyberattacks that may be enabled by advances in networking in the future; next generation nVHDL; and analyzing phenomena in biology and conceptualizing and adapting the underlying principles into engineering problems. His education-related interests include developing a new program in networked information systems engineering (NISE) at the undergraduate and graduate levels; issues in the Ph.D. process; a new approach to instilling critical thinking and creativity in engineering design; and humbleness as a practical vehicle for engineering ethics education. He has held visiting professor positions at Federal University of Rio de Janeiro (Brazil), University of Marseilles (France), and Kuwait University (Kuwait).
