Elizabeth Dauphinee is Lecturer in International Politics at the University of Manchester. David Campbell is Professor of Cultural and Political Geography at the University of Durham, where he convenes the Politics-State-Space research group and serves as Associate Director of the Durham Centre for Advanced Photography Studies and Associate Director of the International Boundaries Research Unit. Professor Campbell’s research deals with the visual culture of international politics, political theory and global geopolitics, and U.S. security policy. He is currently researching a book (tentatively entitled *Humanitarian Visions*) that is concerned with the pictorial representation of atrocity, famine, and war, as well as curating a photographic exhibition on “Imaging Famine” to be held in London in August–September 2005.

Roxanne Lynn Doty is Associate Professor of Political Science at Arizona State University. She is the author of *Imperial Encounters: The Politics of Representation in North/South Relations* (University of Minnesota Press, 1996) and *Anti-Immigrantism in Western Democracies-Statecraft, Desire, and the Politics of Exclusion* (Routledge, 2003). She has contributed articles to *International Studies Quarterly*, *Review of International Studies*, *European Journal of International Relations*, *Security Studies*, *Millennium*, and *Alternatives*. Her research interests include IR theory, immigration and border issues, race, and the politics of writing.

Jenny Edkins is Professor of International Politics at the University of Wales Aberystwyth. Her most recent books are *Sovereign Lives: Power in Global Politics*, with Véronique Pin-Fat and Michael J. Shapiro (Routledge); *Trauma and the Memory of Politics* (Cambridge University Press) and *Whose Hunger? Concepts of Famine, Practices of Aid* (University of Minnesota Press).

Kyle Grayson is Lecturer in the Department of Geography, Politics, and Sociology at the University of Newcastle-Upon-Tyne. Previously, he has served as the Associate Director of YCISS and as a Postdoctoral Fellow of the Canadian Consortium on Human Security. His current research is undertaking a genealogy of assassination with a focus on how the practice has been understood and interpreted in the dominant discourses of global politics.

Engin F. Isin is Professor and Canada Research Chair in the Division of Social Science at York University. His research has focused on the origins and transformations of “occidental citizenship” as a political and legal institution that enables various ways of being political. He is the author of *Cities Without Citizens: Modernity of the City as a Corporation* (Black Rose Books, 1992), *Citizenship and Identity* with Patricia K. Wood (Sage, 1999); *Democracy, Citizenship and the Global City*, ed. Engin F. Isin (Routledge, 2000) and *Being Political: Genealogies of Citizenship* (University of Minnesota Press, 2002). He has also written numerous journal articles, book chapters, technical reports, and public lectures and editorials. His most recent books are coedited with Bryan S. Turner, *Handbook of Citizenship Studies* (Sage, 2002) and with Gerard Delanty, *Handbook of Historical Sociology* (Sage, 2003). His more recent research is on “oriental citizenship and justice” with a focus on Islamic and Ottoman institution, *waqf*.

Mark J. Lacy teaches International Relations at Lancaster University. He is author of *Security and Climate Change: International Relations and the Limits of Realism* (Routledge, 2005) and editor, with Peter Wilkin, of *Global Politics in the Information Age* (Manchester University Press, 2005). He has published

articles on cultural politics and International Relations theory in *Alternatives: Local, Global, Politics and Millennium: Journal of International Studies*.

David Mutimer is Principal Research Fellow in the Centre for International Cooperation and Security of the Department of Peace Studies, University of Bradford (United Kingdom), and Associate Professor of Political Science, York University (Canada). His work aims to bring critical international theory to bear on issues of traditional concern to security studies. Much of his work has concerned weapons proliferation, and more recently issues of small arms and also the American war on terrorism. He has recently published, with a colleague, a piece on popular culture and the contemporary American self, and is completing a book on the production of a post-cold war international security agenda.

Anne Orford is Professor of Law at the University of Melbourne. She researches, teaches, and supervises doctoral students in the areas of international economic law, international human rights law, international law and security, postcolonial theory, legal theory, psychoanalysis and law, and feminist theory. She is Director of Studies for the Master of Law and Development and the Graduate Diploma of Human Rights Law in the Law School's Graduate Program. Anne is the author of *Reading Humanitarian Intervention: Human Rights and the Use of Force in International Law* (Cambridge University Press, 2003), and has published many articles and reviews on critical theory and international law, including in the *American Journal of International Law*, the *European Journal of International Law*, the *German Law Journal*, the *Leiden Journal of International Law* and the *Harvard International Law Journal*.

Kim Rygiel is a doctoral candidate in the Department of Political Science at York University. Her doctoral research investigates post-9/11 citizenship policies and practices as part of a global governing regime regulating mobility. She is coeditor of *(En)gendering the War on Terror: War Stories and Camouflaged Politics* (Ashgate, 2006) and has also published on diasporic citizenship and gender and Turkish and Kurdish nationalism.

Cynthia Weber is Professor of International Relations at Lancaster University. Her work is located at the intersections of international politics, American studies, gender and sexuality studies, and cultural studies.
