## Chapter 2 Governance Regimes and the Fight against Corruption

However, sub-state level politicians may of course also act corruptly, perhaps as they see opportunities to enrich themselves or their allies, or may be as these politicians still maintain links with state-wide leaders who have recently empowered them.
