Andreas Bandak, anthropologist, PhD, assistant professor at Centre for Comparative Cultural Studies, ToRS. His research focuses on the Christian minorities in Syria, where he has done extensive fieldwork in Damascus. His thematic interests include issues of Eastern Christianity, sainthood, and belonging. He has, among other things, recently coedited a special issue of *Ethnos* (vol. 77, no. 4, 2012) entitled “Foregrounds and Backgrounds: Ventures in the Anthropology of Christianity”. In 2010 he received The Danish Ministry of Science, Technology, and Innovation’s Elite Research Travel Stipend.

Jens Dahl, anthropologist, adjunct professor at Centre for Comparative Cultural Studies, ToRS. His long-time research on the Arctic has included the political and economic transformation of communities rooted in a hunting-and-fishing tradition to become diversified, modern urban societies. His thematic research also includes the international movement of indigenous peoples. A major recent work is *Marginalized Indigenous Peoples in the United Nations: The Indigenous Space*, Palgrave Macmillan 2012.

Esther Fihl, anthropologist, dr.phil. professor, Head of Centre for Comparative Cultural Studies at ToRS. Her ethnographic research among fishers of the Coromandel Coast of India has focused on long-term socio-economic transformations. She has done research on cultural encounters, and processes of social inclusion and exclusions. Major recent work is *Exploring Central Asia. From the Steppes to the High Pamirs 1896–1899*, vol. I and II, University of Washington Press 2010.

Lars Funch Hansen, geographer/communication studies, research assistant at Centre for Comparative Cultural Studies, ToRS, He has 20 years of experience in research on the Caucasus, and has performed consultancy work for various international organizations on issues relating to ethnic minorities in the Caucasus and the former Soviet Union. He has worked with civil society development in post-conflict Balkans. He has published in English, Russian, Turkish, and Danish on issues in the Caucasus.

Lars Højer, anthropologist, PhD, associate professor at Centre for Comparative Cultural Studies, ToRS. He has primarily carried out research on transition processes in post-socialist Mongolia and on minority issues related to Western China. He has previously published in *Journal of the Royal Anthropological Institute* (N.S.), *Social Anthropology*, *Inner Asia*, and *Ethnos: Journal of Anthropology*.

Birgitte Schepelern Johansen, sociologist of religion, PhD, assistant professor in minority studies at ToRS, Her research area is the formation of secular identities and secular space in a European context, especially within the academic sphere. She has worked on the integration of formalized imam training and Islamic Theology into the European university system. A recent work is "Counting deviance: Revisiting a Decade's Production of Surveys among Muslims in Western Europe," in *Journal of Muslims in Europe* 1(1) 2012 (with Riem Spielhaus).

Helen Krag, educated in East European Studies, PhD, associate professor emeritus and until recently she was head of Section of Minority Studies at ToRS. She has done research on minority-majority relations in the regions of the former USSR and Eastern Europe, lately with special focus on the North Caucasus. She has published widely in English, Russian, German, Turkish, and Danish on these issues and has acted as advisor for international bodies and human rights organizations.

Dorte Høvids Possing, MA in Scandinavian Studies and Linguistics, PhD and research assistant in minority studies, She did her PhD on computer-mediated communication among Muslim women in Denmark, Britain, and the United States. Her research field is minority-majority relationships, primarily in a Western European context. Her thematic research includes a special focus on current productions of space and place in the context of globalization, Muslims living in non-Muslim majority societies, and mediated representations of minority identity.

Stine Simonsen Puri, anthropologist, PhD fellow at Centre for Comparative Cultural Studies. Her doctoral research is on gambling and

the gambling industry in India based on long-term fieldwork. She focuses on issues related to illegal economy, morality, as well as on gambling addiction. Her overall interest in forms of play is also shown in her previous research on Indian performance traditions, on which she has published a number of articles. In 2011 she received The Danish Ministry of Science, Technology, and Innovation's Elite Research Travel Stipend.

Lars Ove Trans, anthropologist, PhD fellow at Centre for Comparative Cultural Studies, ToRS. His research focuses on indigenous migrants from the state of Oaxaca, Mexico, and their communities of origin and builds on extensive fieldwork in Mexico and the United States. His thematic interests include issues of transnational migration, governance and citizenship. He has, among other things, recently published a chapter on African migrant associations in Denmark in "*Diaspora for Development in Africa*" (edited by Sonia Plaza and Dilip Ratha), The World Bank, 2011.

Margit Warburg, dr.phil, professor in Sociology of Religion. Her research interests are the relationship between religion, migration, and globalization; religion and demography; religious minorities, especially Baha'i; civil religion; and religion among Danes in and outside Denmark. Among her publications are *Citizens of the World. A History and Sociology of the Baha'is from a Globalisation Perspective* (Brill, 2006) and *Holy Nations and Global Identities. Civil Religion, Nationalism and Globalisation*, coedited with Annika Hvithamar and Brian A. Jacobsen, (Leiden, E.J. Brill, 2009).
