- Specialisation: repudiation by the author of denial of necessity *at some stage*, 14; its disadvantages at too early a stage, especially in schools, 17 107; degree of practice in England not imitated elsewhere, 21-2
- Smith, Adam: his views on the advantages and disadvantages of division of labour, 12-14
- Staff expansion: in general not attended with lower intellectual standards but by some ignorance by junior recruits of essential disciplines and procedures, 64-5
- Student-power; its formulation by extremists, 58; illustrated by imaginary conversation, 59
- Student representation: where suitable and where not, 82-3; its especial inappropriateness in matters of standards, finance and appointments, 83-5
- Student's subsequent careers: not all destined to be dons or high experts, 19-20
