Christian Barry (1969) is Editor of *Ethics & International Affairs*. Prior to joining the Carnegie Council, he served for three years as a consultant and contributing author to the *Human Development Report* of the United Nations Development Program. His recent and forthcoming publications include *Applying the Contribution Principle* (in *Global Responsibilities*, Routledge 2005), *Redistribution* (*Stanford Encyclopedia of Philosophy* 2004), “Global Justice: Aims, Arrangements, and Responsibilities” (in *Can Institutions Have Duties?*, Palgrave 2003), and “Education and Standards of Living” (in *Blackwell Companion to the Philosophy of Education*, 2002).

Alexander W. Cappelen (1969), Dr. oecon. from the Norwegian School of Economics and Business Administration (2000), is a post-doctoral fellow at the Department of Economics at the University of Oslo and head of the Centre for Ethics and Economics at the Norwegian School of Economics and Business Administration. He works on topics in public economics, social choice and political philosophy.

Geert Demuijnck (1960), PhD in philosophy from the University of Louvain (Belgium) is professor of ethics and political philosophy at the Catholic University of Lille (France). He publishes on topics related to social justice and social policy.

Andreas Follesdal (1957), PhD in philosophy from Harvard University (1991) is Professor at the Norwegian Centre for Human Rights (Faculty of Law), and at ARENA, a Centre for European Studies, both at the University of Oslo. He publishes and consults on topics in political philosophy, focusing on developments in the European Union.

Rainer Forst (1964), Dr. phil. and Habilitation in philosophy from the Goethe University in Frankfurt, taught philosophy and political science at the Free University in Berlin, the Goethe University, the New School for Social Research in New York, and the Liebig-University in Giessen. He is now Professor of Political Theory at the Goethe University in Frankfurt. Among his publications are *Contexts of Justice. Political Philosophy beyond Liberalism and Communitarianism* (University of California Press 2002) and *Toleranz im Konflikt. Geschichte, Gehalt und Gegenwart eines umstrittenen Begriffs* (Suhrkamp 2003).

Stefan Gosepath (1959) is Privatdozent for philosophy at the Free University in Berlin and visiting professor of philosophy at the University of Potsdam. He works mainly on practical reason and on moral and political philosophy. His books include *Aufgeklärtes Eigeninteresse. Eine Theorie theoretischer und praktischer Rationalität*, (Suhrkamp 1992) and *Gleiche Gerechtigkeit. Grundlagen eines liberalen Egalitarismus* (Suhrkamp 2004).

Wilfried Hinsch (1956), Dr. phil. in philosophy from the University of Hamburg (1984). He was a Visiting Fellow at St. John's College in Cambridge in 1986 and at Harvard University in 1987 and 1988. He taught moral and political philosophy in Münster, Leipzig and Heidelberg, and is currently Professor of Practical Philosophy at the University of the Saarland in Saarbrücken. He also lectures on European Political Philosophy at the Collège d'Europe in Brugge (Belgium). His books include *Erfahrung und Selbstbewusstsein* (Meiner 1986), *Zur Idee des politischen Liberalismus* (Suhrkamp 1992) und *Gerechtfertigte Ungleichheiten. Grundsätze sozialer Gerechtigkeit* (de Gruyter 2002).

Alison M. Jaggar is Professor of Philosophy and Women's Studies at the University of Colorado at Boulder. She works in moral and political philosophy, with an emphasis on feminist philosophy. At present, her main interests are in moral reasoning, especially in contexts of inequality and cultural difference, and in the gendered aspects of global justice theory.

Hilde F. Johnson (1963), Norwegian politician and social anthropologist from the University of Oslo, since 2001 Cabinet Minister of International Development. Ms. Johnson was elected Member of Parliament for the Christian Democrats in 1993 and 1997, and was Norway's Cabinet Minister of International Development and Human Rights 1997–2000.

Regina Kreide (1966), Dr. phil. in philosophy from the Goethe University in Frankfurt. She is research fellow and lecturer in the Department of Social and Political Sciences at Goethe University and currently writing a book on global justice. Among her more recent publications in this area are *The Range of Social Rights* (*German Law Journal* 2001) and *Poverty and Responsibility in a Globalized World* (*Analyse & Kritik* 2003).

Andrew Kuper (1975) was born and raised in South Africa, and holds his PhD from Cambridge University. He has been a Fellow of Trinity College, Cambridge, and a visiting scholar at Harvard and Columbia Universities. Kuper is the author of *Democracy Beyond Borders* (Oxford 2004) and editor of *Global Responsibilities* (Routledge 2005). He is now a Managing Director

at Ashoka – Innovators for the Public, an organization that supports social entrepreneurs around the world.

Jean-Christophe Merle (1964), PhD in Philosophy from the Université de Fribourg, Switzerland (1993). Honorary Professor of Philosophy at the Universität des Saarlandes in Saarbrücken. He coordinates a European network on Applied Global Justice. He is the author of *Justice et Progrès* (Presses Universitaires de France 1997), editor of *Fichte: Grundlage des Naturrechts* (Akademie Verlag 2001) and *Globale Gerechtigkeit / Global Justice* (Frommann-Holzboog 2004), as well as coeditor of *Weltrepublik: Demokratie und Globalisierung* (C. H. Beck 2002), *Modelle politischer Philosophie* (Mentis 2003) and *L'amitié* (Presses Universitaires de France, forthcoming).

Thomas Mertens (1955) is Professor of the Philosophy of Law at the University of Nijmegen, the Netherlands. He has published several articles on Kant's practical philosophy and related issues, as well as on legal theory, especially in relation to Radbruch. He has also translated Kant's *Grundlegung zur Metaphysik der Sitten* and *Zum ewigen Frieden* into Dutch (Boom 1997 and 2004).

Alessandro Pinzani (1966) PhD in philosophy from the University of Tübingen (1997). He is Professor for Ethics and Political Philosophy in the Philosophy Department of the Federal University of Santa Catarina, Florianopolis, Brazil. He publishes on topics in political philosophy, focusing on the history of modern political thought and on theories of democracy.

Thomas Pogge (1953), PhD in philosophy from Harvard (1983). He teaches philosophy at Columbia and Oslo Universities, and is spending 2004–06 as a professorial research fellow at the Centre for Applied Philosophy and Public Ethics, Australian National University. His most recent book is *World Poverty and Human Rights* (Polity Press 2002).

Ser-Min Shei (1961), PhD in philosophy from Columbia University, has been teaching at National Chung Cheng University in Taiwan since 1995. He is working mainly in moral and political philosophy. Among his recent publications are *Political Power, Political Authority and Political Obligation*, as well as *Rawls and the Site of Social Justice*, both written in Chinese and published in *Societas: A Journal of Philosophical Study of Public Affairs*.

Markus Stepanians (1959) studied at Hamburg and as a Visiting Scholar at Harvard from 1991 to 1993. He received his Dr. phil. in philosophy from Hamburg University (1994) and has been teaching philosophy at the University of the Saarland in Saarbrücken since 1998. He is the author of *Frege und Husserl über Urteilen und Denken* (Mentis 1998) and *Frege – Eine Einführung* (Junius 2001, Spanish and French translations forthcoming). Currently he is preparing a collection of essays on rights (to be published by Mentis) and completing a book manuscript *Analyzing Rights. A Defence of the Classical View*.

Henrik Syse (1966) PhD in philosophy from the University of Oslo (1997). He is a senior research fellow at the International Peace Research Institute in Oslo (PRIO), and a postdoctoral fellow at the Ethics Program, University of Oslo. He publishes and consults on topics of international ethics and military ethics and has also done work on professional ethics, Christian ethics and on the history of natural law and natural rights.

Leif Wenar, PhD in philosophy from Harvard University (1997), is Reader in Philosophy at the University of Sheffield. Working in moral and political theory, he has published in *Ethics, Mind, Analysis, Politics, Philosophy and Economics*, the *Columbia Law Review*, and the *Philosopher's Annual*. Wenar has held fellowships at Princeton's Center for Human Values and Tulane's Murphy Institute of Political Economy. In 2004–05, he is a fellow of the Carnegie Council on Ethics and International Affairs.
