With 50,000 TMDLs developed since the CWA's inception, the GAO surveyed state TMDL managers and analyzed a sample of 25 TMDLs. It found that 83 percent of TMDLs were achieving point source reductions, but only 20 percent of TMDLs had met nonpoint source reductions. State coordinators reported that in 35 percent of NPS-only TMDLs, they did not know whether pollution levels had changed.
