Editorial Policy

for the publication of proceedings of conferences and other multi-author volumes

Lecture Notes aim to report new developments – quickly, informally and at a high level. The following describes criteria and procedures for multi-author volumes. For convenience we refer throughout to “proceedings” irrespective of whether the papers were presented at a meeting.

The editors of a volume are strongly advised to inform contributors about these points at an early stage.

§ 1. One (or more) expert participant(s) should act as the scientific editor(s) of the volume. They select the papers which are suitable (cf. §§ 2 – 5) for inclusion in the proceedings, and have them individually refereed (as for a journal). It should not be assumed that the published proceedings must reflect conference events in their entirety. The series editors will normally not interfere with the editing of a particular proceedings volume – except in fairly obvious cases, or on technical matters, such as described in §§ 2 – 5. The names of the scientific editors appear on the cover and title page of the volume.

§ 2. The proceedings should be reasonably homogeneous i.e. concerned with a limited and well-defined area. Papers that are essentially unrelated to this central topic should be excluded. One or two longer survey articles on recent developments in the field are often very useful additions. A detailed introduction on the subject of the congress is desirable.

§ 3. The final set of manuscripts should have at least 100 pages and preferably not exceed a total of 400 pages. Keeping the size below this bound should be achieved by stricter selection of articles and NOT by imposing an upper limit on the length of the individual papers.

§ 4. The contributions should be of a high mathematical standard and of current interest. Research articles should present new material and not duplicate other papers already published or due to be published. They should contain sufficient background and motivation and they should present proofs, or at least outlines of such, in sufficient detail to enable an expert to complete them. Thus summaries and mere announcements of papers appearing elsewhere cannot be included, although more detailed versions of, for instance, a highly technical contribution may well be published elsewhere later. Contributions in numerical mathematics may be acceptable without formal theorems resp. proofs provided they present new algorithms solving problems (previously unsolved or less well solved) or develop innovative qualitative methods, not yet amenable to a more formal treatment.

Surveys, if included, should cover a sufficiently broad topic, and should normally not just review the author’s own recent research. In the case of surveys, exceptionally, proofs of results may not be necessary.

§ 5. "Mathematical Reviews" and "Zentralblatt für Mathematik" recommend that papers in proceedings volumes carry an explicit statement that they are in final form and that no similar paper has been or is being submitted elsewhere, if these papers are to be considered for a review. Normally, papers that satisfy the criteria of the Lecture Notes in Mathematics series also satisfy this requirement, but we strongly recommend that each such paper carries the statement explicitly.

§ 6. Proceedings should appear soon after the related meeting. The publisher should therefore receive the complete manuscript (preferably in duplicate) including the Introduction and Table of Contents within nine months of the date of the meeting at the latest.

§ 7. Proposals for proceedings volumes should be sent to one of the editors of the series or to Springer-Verlag Heidelberg. They should give sufficient information on the conference, and on the proposed proceedings. In particular, they should include a list of the expected contributions with their prospective length. Abstracts or early versions (drafts) of the contributions are helpful.

General Remarks

Lecture Notes are printed by photo-offset from the master-copy delivered in camera-ready form by the authors of monographs, resp. editors of proceedings volumes. For this purpose Springer-Verlag provides technical instructions for the preparation of manuscripts. Volume editors are requested to distribute these to all contributing authors of proceedings volumes. Some homogeneity in the presentation of the contributions in a multi-author volume is desirable.

Careful preparation of manuscripts will help keep production time short and ensure a satisfactory appearance of the finished book. The actual production of a Lecture Notes volume normally takes approximately 8 weeks.

For monograph manuscripts typed or typeset according to our instructions, Springer-Verlag can, if necessary, contribute towards the preparation costs at a fixed rate.

Authors of monographs receive 50 free copies of their book. Editors of proceedings volumes similarly receive 50 copies of the book and are responsible for redistributing these to authors etc. at their discretion. No reprints of individual contributions can be supplied. No royalty is paid on Lecture Notes volumes.

Volume authors and editors are entitled to purchase further copies of their book for their personal use at a discount of 33.3 %, other Springer mathematics books at a discount of 20 % directly from Springer-Verlag. Authors contributing to proceedings volumes may purchase the volume in which their article appears at a discount of 20 %.

Commitment to publish is made by letter of intent rather than by signing a formal contract. Springer-Verlag secures the copyright for each volume.

LECTURE NOTES

ESSENTIALS FOR THE PREPARATION OF CAMERA-READY MANUSCRIPTS



The preparation of manuscripts which are to be reproduced by photo-offset require special care. Manuscripts which are submitted in technically unsuitable form will be returned to the author for retyping. There is normally no possibility of carrying out further corrections after a manuscript is given to production. Hence it is crucial that the following instructions be adhered to closely. If in doubt, please send us 1 - 2 sample pages for examination.

General. The characters must be uniformly black both within a single character and down the page. Original manuscripts are required: photocopies are acceptable only if they are sharp and without smudges.

On request, Springer-Verlag will supply special paper with the text area outlined. The standard TEXT AREA (OUTPUT SIZE if you are using a 14 point font) is 18 x 26.5 cm (7.5 x 11 inches). This will be scale-reduced to 75% in the printing process. If you are using computer typesetting, please see also the following page.

Make sure the TEXT AREA IS COMPLETELY FILLED. Set the margins so that they precisely match the outline and type right from the top to the bottom line. (Note that the page number will lie outside this area). Lines of text should not end more than three spaces inside or outside the right margin (see example on page 4).

Type on one side of the paper only.

Spacing and Headings (Monographs). Use ONE-AND-A-HALF line spacing in the text. Please leave sufficient space for the title to stand out clearly and do NOT use a new page for the beginning of subdivisions of chapters. Leave THREE LINES blank above and TWO below headings of such subdivisions.

Spacing and Headings (Proceedings). Use ONE-AND-A-HALF line spacing in the text. Do not use a new page for the beginning of subdivisions of a single paper. Leave THREE LINES blank above and TWO below headings of such subdivisions. Make sure headings of equal importance are in the same form.

The first page of each contribution should be prepared in the same way. The title should stand out clearly. We therefore recommend that the editor prepare a sample page and pass it on to the authors together with these instructions. Please take the following as an example. Begin heading 2 cm below upper edge of text area.

Please leave THREE LINES blank below heading and address of the author, then continue with the actual text on the same page.

Footnotes. These should preferably be avoided. If necessary, type them in SINGLE LINE SPACING to finish exactly on the outline, and separate them from the preceding main text by a line.

Symbols. Anything which cannot be typed may be entered by hand in BLACK AND ONLY BLACK ink. (A fine-tipped rapidograph is suitable for this purpose; a good black ball-point will do, but a pencil will not). Do not draw straight lines by hand without a ruler (not even in fractions).

Literature References. These should be placed at the end of each paper or chapter, or at the end of the work, as desired. Type them with single line spacing and start each reference on a new line. Follow "Zentralblatt für Mathematik"/"Mathematical Reviews" for abbreviated titles of mathematical journals and "Bibliographic Guide for Editors and Authors (BGEA)" for chemical, biological, and physics journals. Please ensure that all references are COMPLETE and ACCURATE.

IMPORTANT

Pagination. For typescript, number pages in the upper right-hand corner in LIGHT BLUE OR GREEN PENCIL ONLY. The printers will insert the final page numbers. For computer type, you may insert page numbers (1 cm above outer edge of text area).

It is safer to number pages AFTER the text has been typed and corrected. Page 1 (Arabic) should be THE FIRST PAGE OF THE ACTUAL TEXT. The Roman pagination (table of contents, preface, abstract, acknowledgements, brief introductions, etc.) will be done by Springer-Verlag.

If including running heads, these should be aligned with the inside edge of the text area while the page number is aligned with the outside edge noting that right-hand pages are odd-numbered. Running heads and page numbers appear on the same line. Normally, the running head on the left-hand page is the chapter heading and that on the right-hand page is the section heading. Running heads should not be included in proceedings contributions unless this is being done consistently by all authors.

Corrections. When corrections have to be made, cut the new text to fit and paste it over the old. White correction fluid may also be used.

Never make corrections or insertions in the text by hand.

If the typescript has to be marked for any reason, e.g. for provisional page numbers or to mark corrections for the typist, this can be done VERY FAINTLY with BLUE or GREEN PENCIL but NO OTHER COLOR: these colors do not appear after reproduction.

COMPUTER-TYPESETTING. Further, to the above instructions, please note with respect to your printout that

- the characters should be sharp and sufficiently black;
- it is not strictly necessary to use Springer's special typing paper. Any white paper of reasonable quality is acceptable.

If you are using a significantly different font size, you should modify the output size correspondingly, keeping length to breadth ratio 1 : 0.68, so that scaling down to 10 point font size, yields a text area of 13.5 x 20 cm (5 3/8 x 8 in), e.g.

Interline spacing: 5.5 mm base-to-base for 14 point characters (standard format of 18 x 26.5 cm).
