His research on unemployment insurance (UI) has examined experience rating, benefit adequacy, profiling, partial benefits and reemployment bonuses. He has evaluated job training, wage subsidies, public works, self-employment, and employment service programmes for labour ministries in Canada and the economic transition countries of Hungary, Poland, Serbia, and China. For the US Department of Labor he developed a prototype frontline decision support system for one-stop career centres under the Workforce Investment Act, and analysed practical aspects of implementing personal reemployment accounts. His research has also been sponsored by the World Bank, ILO and OECD. Currently, for the US Department of Health and Human Services he is investigating the use of UI by recent recipients of Temporary Assistance to Needy Families (TANF), and for the US Department of Labor he is studying recent trends in UI use based on state administrative records.
