The model is capable of producing frequency locking, quasi-periodic motion, and chaos. The tools of analysis are classical perturbation methods (Poincaré-Lindstedt). Occasionally methods developed for the analysis of chaotic systems, such as symbolic dynamics, and catastrophe theory are used.
