Josef Aschbacher is the Head of the GMES Space Office of the European Space Agency, which is located at ESA ESRIN in Frascati, Italy. Before, from 2001 to 2006 he was Programme Coordinator in the Directorate of Earth Observation Programmes at ESA's HQ in Paris. He was at the Space Applications Institute at the EC Joint Research Centre in Ispra, Italy, from 1993 to 2000, where he was the Scientific Assistant to the Director in his last position. Through his work at the EC and ESA he earned a profound knowledge of the Earth Observation landscape in Europe and has actively contributed to the advancement of European space programmes, most notably the Global Monitoring for Environment and Security (GMES) initiative. Josef Aschbacher has a Ph.D. and Masters degree in Natural Sciences from the University of Innsbruck, Austria. He has 25 years of working experience in the domain of satellite Earth observation and has published more than 100 articles, many in peer-reviewed journals. He has been a lecturer at University Innsbruck, Austria, the Asian Institute of Technology in Bangkok, Thailand, the Politecnico Milano, Italy, and the University of Wuerzburg, Germany.

Blandina Baranes joined the European Space Policy Institute (ESPI) in Vienna in February 2005. She is the librarian and documentalist of ESPI. Before she was the chief librarian of the Jewish Studies Department at the University of Vienna. During the past years she has been working as documentalist and librarian for different institutions such as, The Austrian Broadcasting Corporation, DER SPIEGEL and others. She conducted her studies and research in Austria and Israel and graduated with an Master from Vienna University, Faculty of Philosophy, Department of Social and Cultural Anthropology.

Frans G. von der Dunk is the Harvey and Susan Perlman Alumni/Othmer Professor of Space Law at the University of Nebraska-Lincoln's L.M. Programme on Space and Telecommunication Law. He also is Director of Black Holes BV, Consultancy in space law and policy, based in Leiden. Previously, he was Co-Director, then Director of Space Law Research at the International Institute of Air and Space Law at Leiden University since 1990. He has written well over 120 articles and published papers, has given more than 100 presentations at international meetings and was visiting professor at some 25 foreign universities across the world. As of 2006, he is the Series Editor of 'Studies in Space Law', published by Brill. Finally, he has given a range of interviews to the international media on issues of space law and policy. Prof. von

der Dunk has served as adviser to the Dutch Government, several foreign Governments, the European Commission, the European Space Agency (ESA) and other international organisations. He is Director Public Relations of the International Institute of Space Law (IISL), Member of the Board of the European Centre for Space Law (ECSL), and Member for the Netherlands in the International Law Association's (ILA) Committee on Space Law. He is also Member of the International Editorial Board of "Space Policy".

Florian Hafner is Research Associate at the Department of European, International and Comparative Law at the Law Faculty (intlaw.univie.ac.at) of the University of Vienna since January 2009. He studied law and business administration in Vienna and Sydney. In 2008 he finished his law degree at the University of Vienna in 2006 he finished his degree in Business Education at the Vienna University of Economics and Business Administration. He has been working for different Austrian law firms and tax consultant offices. Currently he is working at the National Point of Contact (NPOC), Austria of the European Center for Space Law (ECSL) and writing his doctoral thesis on a new Austrian space law.

Ram S. Jakhu is Associate Professor at the Institute of Air and Space Law, Faculty of Law, McGill University, Montreal, Canada. He teaches and conducts research in international space law, law of space applications, law of space commercialisation, government regulation of space activities, law of telecommunications, Canadian communications law, and public international law. He is also Director of Research for the Space Security Index, the managing editor of Space Regulations Library Series, a member of the Editorial Board of the *Annals of Air and Space Law*, a member of the Board of Director of the International Institute of Space Law and a Fellow and the Chairman of the Legal and Regulatory Committee of the International Association for the Advancement of Space Safety. He has served as Director of the Centre for the Study of Regulated Industries at McGill University (1999–2004) and as Professor and the first Director of the MSS Programme of the International Space University in Strasbourg, France (1995–1998). Professor Jakhu holds a BA, an LLB and an LLM from Panjab University and an LLM and a DCL from McGill University.

Srikanth Kondapalli is Professor in Chinese Studies at Jawaharlal Nehru University. He is also an Honorary Fellow at Institute of Chinese Studies, Delhi and Research Associate at Centre for Chinese Studies, University of Stellenbosch, South Africa. He served at Institute for Defence Studies & Analyses, New Delhi for nearly 12 years. He is educated in Chinese studies in India and China with a specialisation in Modern Chinese History in Master of Arts at Osmania University at Hyderabad, Master of Philosophy and Doctor of Philosophy in 1989 and

1995 respectively in Chinese Studies Division of School of International Studies, Jawaharlal Nehru University, New Delhi. He learnt Chinese language at Beijing Language & Culture University and was a post-Doctoral Visiting Fellow at People's University, Beijing from 1996 to 1998. He was a Visiting Professor at National Chengchi University, Taipei in 2004, a Visiting Fellow at China Institute of Contemporary International Relations, Beijing in May 2007 and an Honorary Professor at Shandong University, Jinan. He has published two books, two monographs, co-edited two volumes and several articles in edited books and in national and international journals and newspapers. He is a guest faculty member at India's Foreign Service Institute, National Defence College, Army War College, College of Naval Warfare, College of Air War, Indo-Tibetan Border Police Academy and Border Security Force Academy.

Sascha Lange is a research associate and political consultant at the German Institute for International and Security Affairs (SWP) in Berlin since 2005. He is currently working at the research unit European and Atlantic Security and conducting research on global military capabilities, Aero-, space and armaments industries and chemical and biological weapons. This includes a project for the „Zentrum für Transformation der Bundeswehr“ (The Bundeswehr Transformation Centre). The topic of the research project is the German equivalent to NCW, „Vernetzte Operationsführung – NetOpFü“. Selected publications in English include following papers: Europe's Reaction to the “Augustine Report”, The End for the Airbus A400M?, Missile Defense in and for Europe?, SAR-Lupe Satellites launched, Partial Capability Loss through MEADS. In previous positions, he served as an intern at the Institute for Peace Research and Security Policy University Hamburg (1999) and at the SWP, before getting a scholarship from the Forum Ebenhausen to conduct research within the SWP. He holds a biology degree from Bremen University (Germany) and wrote his thesis on the “Detection and analysis of biological weapons”.

Irmgard Marboe is Associate Professor of International Law at the Department of European, International and Comparative Law at the Law Faculty of the University of Vienna. She is the head of the National Point of Contact for Space Law in Austria and member of ECSL and IISL. She regularly participates in the Legal Subcommittee of UNCOPUOS and has been elected to be the chairperson of the Working Group under the agenda item on “National legislation relevant to the peaceful exploration and use of outer space” between 2009 and 2011. Her research in the area of space law has so far focused on telecommunication and space, national space legislation, European space policy and authorisation of space activities. Her current teaching activities at the University of Vienna

include courses and seminars on general international law, international economic law, international courts and tribunals, and space law.

Bertrand de Montluc is presently Associate Professor at “Sciences Po” (I.E.P.) Paris school of higher education specialised in economics and political sciences (Europe-Asia Undergraduate cycle, lecture on Science, Technology & Society). He is research fellow at the CERI, University of Paris Center for International Relations Studies (international governance of nano-biotechnologies). He also acts as president of the strategy and international affairs committee of the non-profit professional organisation “3AF” (Aeronautical and Astronautics Association of France). In his previous functions he was Space and Technology senior analyst at the French Foreign Affairs Ministry’s Policy planning staff (C.A.P.) and advisor for the director of Strategic affairs (D.A.S.) of the French Ministry of Defense. Before that, for four years he held the position of space & technology counsellor at the Brussels French Diplomatic Delegation to the E.U. (1999–2003). From 1981 to 1999 he worked at the French Space Agency C.N.E.S. as head of the international relations department, then as Deputy Director for strategy and European cooperation (ESA and bilateral relations). Dr. de Montluc graduated from the Sciences Po and has a doctorate in law (PHD in international law). He has been honoured as “chevalier” of the National Order of Merit. He is the author of more than 100 publications in the field of space policy, international affairs, defense and security.

Scott Pace is the Director of the Space Policy Institute and a Professor of Practice in International Affairs at George Washington University’s Elliott School of International Affairs. From 2005 to 2008, he served as the Associate Administrator for Programme Analysis and Evaluation at NASA. Prior to NASA, Dr. Pace was the Assistant Director for Space and Aeronautics in the White House Office of Science and Technology Policy (OSTP). From 1993 to 2000, Dr. Pace worked for the RAND Corporation’s Science and Technology Policy Institute (STPI). From 1990 to 1993, Dr. Pace served as the Deputy Director and Acting Director of the Office of Space Commerce, in the Office of the Deputy Secretary of the Department of Commerce. He received a Bachelor of Science degree in Physics from Harvey Mudd College in 1980; Masters degrees in Aeronautics & Astronautics and Technology & Policy from the Massachusetts Institute of Technology in 1982; and a Doctorate in Policy Analysis from the RAND Graduate School in 1989. Dr. Pace received the NASA Outstanding Leadership Medal in 2008, the U.S. Department of State’s Group Superior Honor Award, *GPS Interagency Team*, in 2005, and the NASA Group Achievement Award, *Columbia Accident Rapid Reaction Team*, in 2004. Dr. Pace is a currently a

member of the Board of Trustees, Universities Space Research Association and a Corresponding Member of the International Academy of Astronautics.

Walter Peeters is Dean and Vice-President for Academic Affairs at the International Space University (ISU) at Strasbourg, France. After initial management positions in construction and the petrochemical industry, he joined the European Space Agency (ESA) in 1983 in a number of project control and management functions, among others in the HERMES project in Toulouse, France. From 1990, he was involved in astronaut activities as Head of the Coordination Office of the European Astronaut Center in Cologne, with strong involvement in the EUROMIR missions. He joined ISU in 2000, after serving as Visiting Professor (Non-profit Marketing) at the University of Louvain, Belgium and was nominated as Dean of ISU in 2005. He has published more than 50 articles on incentive contracting, project management, space commercialisation and organisation in the space sector and is author of the book *Space Marketing* (Kluwer, 2000). Recent consultancy assignments include activities in the field of space economy (OECD, EC), space policy (Luxemburg, Estonia) and space tourism (Singapore spaceport, Galactic Suite, Excalibur). He holds bachelor's degrees in engineering and applied economics (Catholic University of Louvain), a Master of Business Administration degree (Louvain, Cornell University) and a Ph.D. in Industrial Organisation (TU Delft, the Netherlands). He has been recently appointed as Director of the International Institute of Space Commerce (IISC), a think-tank based on the Isle of Man as a joint project between ISU and the Isle of Man government.

Wolfgang Rathgeber studied Electrical Engineering at the universities of Erlangen (Germany), Campinas (Brazil) and Valencia (Spain). He has been with the German Aerospace Centre (DLR) since 1999. Until 2003, he was a doctorate student at the Institute of Radio Frequency Engineering and Radar Systems in Oberpfaffenhofen (Germany) with a thesis on high resolution signal processing for Synthetic Aperture Radar (SAR). From 2003 until 2005, he was scientific staff member at the European Academy of Technology Assessment Bad Neuenahr-Ahrweiler (Germany). Since 2005 he has been seconded to the European Space Policy Institute (ESPI) in Vienna (Austria), where he is in charge of security topics.

Kai-Uwe Schrogel is the Director of the European Space Policy Institute (ESPI) in Vienna, Austria since 1 September 2007. Prior to this, he was the Head of the Corporate Development and External Relations Department in the German Aerospace Center (DLR). Previously he also worked with the German Ministry for Post and Telecommunications and the German Space Agency (DARA). He has been a delegate to numerous international forums and recently served as the

chairman of various European and global committees (ESA International Relations Committee and two UNCOPUOS plenary working groups). He presented, respectively testified, at hearings of the European Parliament and the U.S. House of Representatives. Kai-Uwe Schrogl has written or co-edited 12 books and more than 130 articles, reports and papers in the fields of space policy and law as well as telecommunications policy. He is editor in chief of the “Yearbook on Space Policy” and the book series “Studies in Space Policy” both published by ESPI at SpringerWienNewYork. In addition he sits on editorial boards of various international journals in the field of space policy and law (*Acta Astronautica*, *Space Policy*, *Zeitschrift für Luft- und Weltraumrecht*, *Studies in Space Law/Nijhoff*). Kai-Uwe Schrogl is a Member of the Board of Directors of the International Institute of Space Law, Member of the International Academy of Astronautics (recently chairing its Commission on policy, economics and regulations) and the Russian Academy for Cosmonautics. He holds a doctorate degree in political science and lectures international relations at Tübingen University, Germany (as an Honorary Professor). He has been a regular lecturer at, for example, the International Space University (where he serves as Adjunct Faculty) and the European Centre for Space Law’s Summer Courses.

Jürgen Turek is Deputy Director of the Center for Applied Policy Research (C•A•P) at the Ludwig-Maximilians-University in Munich. He there also heads from 1998 up today the Research Group on the Global Future. In addition, from 2001 to 2005, he was Book Editor for the book review section of the German journal “*Internationale Politik*”, which was published monthly by Deutsche Gesellschaft für Auswärtige Politik (DGAP; German Council on Foreign Relations) in Berlin in this period. Previously and besides his studies, from 1981 to 1987, he was a Documentary Editor at the Bundespresseamt der deutschen Bundesregierung (BPA Press and Information Office of the German Federal Government), from 1988 to 1991, a Research Fellow at the Department of Political Science at the University of Mainz and, from 1991 to 1992, a Press Officer at the Cologne Fair Ltd. in Cologne. Between 1993 and 1995, Jürgen Turek was involved in various projects of the C•A•P as a Research Fellow. Before his appointment to his current positions there, he was the Deputy Director of Bertelsmann Research Group on Policy Questions from 1995 to 1998. He has published three books (Co-Author with Werner Weidenfeld) on the current state of competition policy in Europe and social. In addition, he published numerous articles on European research and technology policy (e.g. since 1993 in the *Yearbook of European Integration (Jahrbuch der Europäischen Integration)* change as well as a Study Letter on the Research and Technology Policy in Europe for the Fachhochschule Fernstudienverbund der Länder, East Germany)

and important issues of the future have been published in books, journals and newspapers, including the “Frankfurter Allgemeine Zeitung”, “Handelsblatt”, “Das Parlament” and “Internationale Politik” Jürgen Turek holds an M.A. from the Johannes Gutenberg University of Mainz in political science, journalism and sociology.

Christophe Venet is a Ph.D. candidate at the Institute for Political Science at Tübingen University, Germany and an Associate Fellow of the European Space Policy Institute (ESPI) since January 2010. In 2009, he was Research Assistant at the Institute. In this capacity, he contributed to the Report “Space Policies, Issues and Trends in 2008/2009”. He also worked on the issue of space commerce and space entrepreneurship, preparing several presentations on these issues. He was invited to become a peer-reviewer for the journal “Acta Astronautica” in August 2009. He graduated from the Institut d’Etudes Politiques de Strasbourg, France, and studied international relations at the Moscow State Institute of International Relations (MGIMO), Russia. He also holds a Masters degree in Peace Studies and International Politics from Tübingen University. His dissertation deals with EU policy in the field of space security, focusing on the actorness of Europe and on interests and norms underlying the policy processes within the European Space Policy.
