Salim Akoojee is a visiting associate professor at the University of the Witwatersrand, Johannesburg, and honorary lecturer at the University of KwaZulu-Natal (South Africa). He manages the research and development responsibility at the manufacturing, engineering and related services Sector Education and Training Authority (merSETA). He has published in numerous national and international academic journals and has authored a number of books and monographs, including the seminal work, *Vocational Education and Training in Southern Africa: A Comparative Study*. He currently serves as senior consultant editor of the *Africa Education Review*.

Philippe Astier is a professor at the ISPEF (Institute for Science and Practice in Education and Training), University Lumière-Lyon 2. His domains of research deal with adult training and more specifically the relationship between activity, experience and training. Among his research interests are narrative and experience, alternation, competence transmission, accreditation of prior and experiential learning. Philippe Astier coordinated a certain number of review issues such as *Education Permanente* and is the author of numerous papers on work analysis, experience and competence development. She has been working on major studies on vocational education and training across Europe and has published widely, including in the Oxford Review of Education. Her research interests include biographical approaches to youth transitions and learning and identity.

Joanna Burchert is a researcher and PhD student at the Institute Technology and Education (ITB) at University of Bremen, Germany. Her fields of study include school and teaching development, pedagogical quality management, qualitative research methods and research on pedagogical self-concepts of trainers in vocational education.

Len Cairns is an associate dean at Monash University, Australia, and is a visiting professor at the Institute for Work-Based Learning at Middlesex University. Len has also worked as a visiting professor and visiting scholar at international universities in the United Kingdom, USA, Europe, Macedonia and India. Major current research and teaching activities are in Capability, Leadership and Management; Organisational Change and Development; and International Education, with reference to development of Global Capability, Workplace Learning, Learner-Managed Learning and Self-Efficacy.

Linda Clarke is a professor of European Industrial Relations at the Westminster Business School, University of Westminster, where she undertakes research on training, skills, wage and labour relations in Europe, particularly in the construction sector. Her publications include *Vocational Education: International approaches, developments and systems*, with Christopher Winch, Routledge 2007.

Ludger Deitmer is the head of department ‘regional development of VET and innovation research in VET’ at the Institute Technology and Education (ITB), University of Bremen. His fields of major research interest are management of innovation in VET in enterprises, school and development networks, evaluation of VET programmes and in pilot projects and methodological design of vocational training processes; he is also convenor of the European Vocational and Education Research network within the European Association of Educational Research (EERA).

Pascaline Descy is a senior expert at Cedefop, the European Centre for the Development of Vocational Training, an agency of the European Union based in Thessaloniki, Greece. She is intensively involved in VET research and has edited Cedefop’s VET research reports for a number of years.

Michel Eraut is an emeritus professor of Education at the University of Sussex, UK. He is a leading researcher into how professionals learn in workplace settings. His pioneering research has found that most learning occurs informally during normal working processes and that there is considerable scope for recognising and enhancing such learning. His research interests include the nature of professional knowledge; the epistemology of practical knowledge; the enhancement of informal learning; the initial and continuing education of managers, professionals and technicians; the relationship between theory and practice; and the learning organisations. His recent work on learning trajectories concerns the ongoing support of learners in contexts where employers and universities take over the 'official learning routes' without supporting learners' needs to become more proactive in their work.

Edda Grunwald is a GTZ programme manager for the Mubarak Kohl Initiative for vocational education, training and Employment Promotion (MKI-vetEP). Her domain is capacity and organisational development in the context of TVET and labour market policies in developing countries (long-term assignments in China, Indonesia, South Africa, Egypt). She started her career as mathematician. Based on further studies (linguistics and andragogy), she entered the field of teaching and teacher training.

Donglian Gu is a senior lecturer, teacher and a research staff of VET Teaching & Research Office Guangzhou and has worked in the field of vocational education, especially curriculum development, teaching research and guidance of the teachers.

Xu Han is a professor and director of the Institute for Vocational Education on Shenyang Normal University, board member in the Chinese Society of Vocational and Technical Education (CSVTE), member of the scientific committee of CSVTE, vice leader of the research committee of CSVTE and vice leader of the vocational education association in Liaoning province. Since 1990, her focus is on research and teaching in vocational education pedagogy. Her areas of research are basic theory of vocational education, international comparative research of vocational education and curriculum research.

Her main research interests are international comparative studies and the research on competence development including the development of vocational identity and commitment. Specific initiatives studied include TVEI, GNVQ, the specialist schools programme and vocational projects within the Superhighways Initiative. The Post-14 Research Group has recently completed the national evaluation of 14-19 pathfinders and the national evaluation of the applied learning specialist schools programme.

Ute Hippach-Schneider is a researcher and project manager in the 'International Monitoring and Benchmarking/European VET Policy' section at BIBB, the Federal Institute for Vocational Education and Training in Bonn, Germany.
