

## CONTRIBUTING AUTHORS

Elementa, 1997) dedicated to Eugen Fink, called : *Eugen Fink. Actes du Colloque de Cerisy-la-Salle 23-30 juillet 1994*, and is in charge of the translation of extensive texts from the three

Volumes of *Husserliana* dedicated to Intersubjectivity (Grenoble, Millon 1998, and forthcoming Paris, P.U.F., Epiméthée).

She is the founder (1993) and the co-editor of the annual Journal of Phenomenology *Alter*, has just completed a book entitled *Ecrire en phénoménologie, Une autre "époque de l'écriture"* (forthcoming with Encre Marine, Fougère, France, 1999), and is currently completing a book about body and embodiment from a transcendental perspective, provisionally entitled *Lucidité du corps. Pour un empirisme transcendantal en phénoménologie*. Last but not least, she is the co-author (with F.J.Varela and P. Vermersch) of a joint-volume called *On becoming aware. Steps to a phenomenological pragmatics*, forthcoming with MIT Press.
