

Kathryn Backett-Milburn is Professor of the Sociology of Families and Health in Community Health Sciences and the School of Health in Social Science at the University of Edinburgh, Scotland. She is also co-director of the Centre for Research on Families and Relationships (CRFR). Kathryn is a qualitative research specialist currently involved in research into children, families and work–life balance using qualitative longitudinal research methods (she is a PI and heading up the User Engagement strand for the ESRC Timescapes QLR Study); social class, family and the adolescent diet; work–life balance issues for women; qualitative understanding of demographic issues in Scotland; and research with ChildLine Scotland.

Helene Brembeck is Professor of Ethnology and co-director of the Center for Consumer Science (CFK) at Göteborg University, Sweden. The focus of her research interest encompasses parenthood and childhood in consumer culture, food, eating and ethnicity. She has published several books and anthologies in this field including *Little Monsters: (De) Coupling Assemblages of Consumption* (2007, LIT Verlag, co-edited with Karin M.
