There has been increased attention to children and development, and children's development, in international policy debates in recent years, reflected in the United Nations Convention on the Rights of the Child and the child-centred focus of United Nations' Millennium Development Goals. However, despite this increasing focus on policies and programmes (and budgets) to support children, relatively little has been written to draw together the lessons of development policy and practice as well as research into children's development over the life-course.

This series will start off with a mini series of three books from Young Lives, a unique 15-year longitudinal study of childhood poverty in developing countries. It will also incorporate other edited or single-author volumes, from a range of disciplines, which relate to and reflect the work being done by Young Lives on children and development, but broaden debates into the wider childhood studies field. A particular strength will be the ability to bring together material that links issues from developed and developing countries, as they affect children. As such the series will present original and valuable new data for an important and growing field of scholarship.



Contributors

Jere R. Behrman is the W.R. Kenan, Jr. Professor of Economics and Sociology and Research Associate of the Population Studies Center at the University of Pennsylvania. His research is in empirical microeconomics, economic development, labour economics, human resources (education, training, health, nutrition), economic demography, household behaviours, life-cycle and intergenerational relations, and policy evaluation. He has published more than 330 professional articles and 33 books. He has been a research consultant with a number of international organizations, involved in research or lecturing in over 40 countries, a principal investigator on over 70 research projects, and received a number of honours for his research.

Michael Bourdillon studied Social Anthropology at Oxford University, and taught for over 25 years in the Department of Sociology at the University of Zimbabwe, where he is now Emeritus Professor. For the past 20 years, he has been involved with street and working children, both as an academic and a practitioner. Recent among his many publications is the co-authored book, *Rights and Wrongs of Children's Work* (2010).

Jo Boyden is an anthropologist and Director of Young Lives and a Reader in Development Studies in the Department of International Development at the University of Oxford. Her work with Young Lives since 2005 has focused on children's experiences of poverty, particularly the relationship between poverty and other forms of childhood risk, the political-economic processes that underpin the distribution of risk, the role of subjective perceptions in mediating outcomes, and children's contributions to household risk reduction. Her previous research centred on child labour and young people living with armed conflict and forced migration.

Karen Brock is a social scientist, writer, and editor, focusing on natural resource management issues, development policy processes, social accountability, and participatory governance. Her publications include *Knowing Poverty: Critical Reflections on Participatory Research and Policy* (2002) and *Unpacking Policy: Knowledge, Actors and Spaces in Poverty Reduction in Uganda and Nigeria* (2004).

Laura Camfield is Lecturer in the School of International Development at the University of East Anglia. She specializes in research methods to understand and measure well-being in developing countries, including the way people experience poverty and develop resilience. Laura holds an ESRC Comparative Cross-National Research Methods grant (2010–14) to develop and share methods for the collection of data on these topics based on her earlier work with Young Lives and the Well-being in Developing Countries research group (www.welldev.org.uk).

Santiago Cueto is Senior Researcher at GRADE (the Grupo de Análisis para el Desarrollo), Lima in the areas of education and human development, and coordinator of the Young Lives study for Peru. He is also Professor at the Pontificia Universidad Católica del Perú (PUCP), President of the Peruvian Society for Educational Research, and a member of the National Council of Education in Peru.

Gina Crivello is a Research Officer with Young Lives. She has a PhD in Anthropology from the University of California, where her research focused on the role of gender in youth migration from Morocco to Europe. In Young Lives, she has explored children's mobilities and migration in relation to their experiences of school and work, and the responsibilities they have within their families.

Andrew Dawes is an applied developmental psychologist with affiliations to the Universities of Cape Town and Oxford. He has a long-standing interest in the development of an evidence-base for policies and interventions to improve the situation of children who are rendered vulnerable to poverty and violence.

Stefan Dercon is Professor of Development Economics at the University of Oxford, and leads the poverty dynamics research stream within Young Lives. He has worked extensively on risk and poverty in Ethiopia, Tanzania, and India, using longitudinal and long-term cohort data. His work on children has focused on risk, nutrition, schooling, and psychosocial competencies, and their role in the persistence of poverty.

Patrice Engle is Professor of Psychology and Child Development at Cal Poly State University. She specializes in care practices and child nutrition, responsive feeding, HIV and AIDS, and women's empowerment from the perspective of early childhood development. She has worked for the World Health Organization, and for UNICEF in India and New York. She has recently prepared an updated review on the effectiveness of programmes to improve early child development in low- and middle-

income countries and is currently developing assessment tools for child development for Latin America and for East Asia.

Deborah Ewing is a consultant and specialist in child-focused methodologies.

Paul Glewwe is Professor at the University of Minnesota's Department of Applied Economics. Earlier he was a research economist at the World Bank. His research focuses on economics of education, poverty, and inequality in developing countries. His recent publications have appeared in many reputable journals and volumes, including the *Economics of Education Review*, *Handbook of Development Economics*, *Handbook of the Economics of Education*, *International Encyclopedia of Education*, *Journal of Development Economics*, *The Lancet*, and *World Bank Economic Review*.

Gabriela Guerrero is Associate Researcher at GRADE and a doctoral candidate in Educational Sciences at the Catholic University of Leuven in Belgium.

Gillian Mann is a freelance child protection consultant. She trained in education at Harvard University and in anthropology at the London School of Economics and Political Science, where her PhD thesis was entitled 'Being, Becoming and Unbecoming a Refugee: The Lives of Congolese Children in Dar es Salaam'.
