# Acknowledgements

Although writing and historical research is a solitary occupation, its practitioners nonetheless work within a broader scholarly community that provides valuable support. I have incurred substantial debts to a variety of institutions and other scholars in the course of writing this book. The project began at the University of Virginia when a research paper for Enno Kraehe on opposition views of British foreign policy during the Napoleonic Wars led me into the byways of early nineteenth century domestic politics in Britain and the role of the Whig party. The late Martin Havran encouraged me to pursue a growing interest in party politics, and no adviser could have done more than Nicholas Edsall to encourage a student's intellectual independence. Both gentlemen provided invaluable advice on British archives and the personalities discussed in my book. Their comments on the dissertation from which this manuscript emerged strengthened it tremendously. Stephen Schuker trained me in diplomatic history at the University of Virginia and imbued me with standards of scholarship for which I will ever remain grateful. I am honoured to count him a friend, and his critical analysis and questioning helped me set developments in British politics during the second and third decades of the nineteenth century within the broader context of European and Atlantic history.

James Sack and John Severn offered welcome advice and companionship during my archival research in London. Professor Sack kindly gave the manuscript a line-by-line reading and encouraged me to read through the provincial press. Richard Davis and Harry Dickinson also provided invaluable guidance on sources and fielded questions as I began the project. William Banks Taylor put at my disposal his research on debates among the Whigs over foreign policy and the career of Francis Horner and Lord Thanet. Charles Perry, John Hutcheson, Samuel Williamson, and Jeremy Black directed me to sources, offered comment on my views and assisted me in overcoming barriers to research. Jonathan Steinberg, Matthew Davis, Paul Gottfried, and Jennifer Siegel each set aside their work in other fields to comment on my draft. Mary Katherine Barbier saved me from occasional infelicities of language as I prepared the final draft, and Pamela Edwards, Philip Harling, Arthur Herman, and Jonathan Clark each took the time



to read the entire manuscript and offer comments based on their deep knowledge of the long eighteenth century in British history.

Much of the book was written during my time as a research fellow at the Foreign Policy Research Institute in Philadelphia. The trustees, fellows, and staff at FPRI provided a congenial and intellectually stimulating working environment for three years, and Charles B. Grace Jr, Alan and Jan Luxenberg, and Harry Richlin merit special thanks for their kindness. Dr Harvey Sicherman, FPRI's President, encouraged my efforts with advice and often applied his years of government experience to illuminating my questions on an earlier era. My colleagues Walter McDougall and James Kurth also took time from their busy schedules to discuss the Whig Revival from the perspectives of American history and political science. Their comments and criticisms made the final manuscript far better than it would have otherwise been.

I would like to thank Dr Godfrey Uziogwe, Head of the History Department at Mississippi State University, for providing a generous grant to cover the cost of illustrations. Besides assisting me with a grant for this project, Dr Uziogwe has combined with other faculties and Dr Phil Oldham, Dean of the College of Arts and Sciences, to foster a commitment to research and scholarship at Mississippi State that deserves special recognition.

I also wish to express my deep appreciation to the archivists and librarians who assisted my research, especially the staff at the University of Virginia's Alderman Library. Lew Purifoy, Holly Shifflet, and Peggy Holley in the Interlibrary Services Department at Alderman demonstrated great facility in locating obscure pamphlets and memoirs, along with cheerful patience with my requests.
