Notes on the Contributors

Erzsébet Barát is Associate Professor in Gender Studies and Linguistics at the University of Szeged, Hungary. Her research has been on the Americanization of Australian English, Hungarian women's life stories and research ethics, and racism in the Hungarian media. She has contributed articles in these areas to the *Journal of Gender Studies*, *HELIKON*, and to A. Donnell and P. Polkey (eds), *Representing Lives: Women and Auto/biography* (Palgrave Macmillan, 2000).

Concepción Gómez Esteban obtained her doctorate in Sociology, and specializes in Psychoanalytic Theory. She is Assistant Professor of Sociology at the Universidad Complutense de Madrid. She has carried out extensive research in the fields of the sociology of knowledge and the sociology of death. Since 1993, she has devoted most of her research activity to fields related to women and paid work, especially women in positions of management and leadership.

She has published several articles in journals and has had two books published in Brazil, *The Multiple Facets of Language* (1996) and *You and I: The Constitution of the Subject in Medical Discourse* (2000).

Luisa Martín Rojo is an Associate Professor of Linguistics at the Universidad Autónoma de Madrid. She applied sociolinguistic and pragmatic perspectives to research on the languages of minorities in Spain.
