# Acknowledgments

This book owes an enormous debt to a huge number of people who made a gigantic difference.

The financial support for this work came from the National Science Foundation, the Institute for International Education, Texas A and M University and the Universidade Federal Fluminense. The National Science Foundation provided two separate \$70,000 grants to do the fieldwork associated with this study. The Institute for International Education and the Universidade Federal Fluminense collaborated to support a Fulbright Grant in Niteroi in 2002. This became the base for the fieldwork in Aracaju, and Cuiabá as well as much of the work with census materials in Rio. Texas A and M provided sabbatical support as well as multiple small grants to support shorter trips and undergraduate labor.

Three individuals were absolutely essential to making this project feasible.

Fernando Sá of the History Department of the Universidade Federal de Sergipe made the entire barber component of this project possible. He introduced me to the barbers of Aracaju; he trained me in the use of Sergipano archives; he patiently explained the aspects of Sergipana history that were fundamental to my understanding the labor markets of the time; he set up the collaboration with SENAC-Sergipe that led to the critical wave of interviews on the survival strategies of beauticians, and he vastly increased my knowledge of social movements, progressive social change in Brazil and the history of Brazilian popular culture. He has made substantial efforts to document and archive the oral histories of the Sergipe barbers – to provide a lasting resource for future generations of social historians. My debt of gratitude to Fernando Sá is overwhelming.

Jenny Barbosa of the Universidade Federal de Sergipe business school was instrumental to the analysis of hotels and restaurants. An expert on tourism in the Brazilian northeast, her insights on Nordeste business conditions and the struggles of the Northeast to become established as a center of tourism are fundamental to my thinking today. She generously made the facilities of the Business School available to me in my research – and the facilities of her home. She provided multiple opportunities to speak publicly in academic settings. She herself gave some months of her time to collaborating on cognate research on

tourism development in Espírito Santo and Alagoas. She introduced me to a vast number of people, many of whom provided me with crucial interviews. However, her primary contribution was intellectual. In the early stages of the project, few people did more to educate me on the dynamics of hotels and restaurants – causing me to abandon a vast number of ill-informed ideas.

Marcilio Brito, Professor of Tourism at Pío X, with a long record of public service in tourism policy and development, was equally fundamental. He traveled with me to Recife and to Brasília to obtain critical data. Several fundamental statistical analyses would have been impossible without the datasets he was miraculously able to obtain. He put me up in his home. He too was a critical part of the early education process, particularly on the history of state policy concerning tourism. He did cognate research on Pernambuco and Rio Grande do Norte which changed much of my thinking on the state and development – including digging up uncomfortable historical facts which did not fit my pat models. He is also an accomplished poet and a sophisticated man of the arts. My appreciation of Brazilian literature, music and gastronomy would not be the same without him.

Silvia Matos and Eduardo Teles (the Brazilian undergraduate, not the similarly named Princeton professor who also, incidentally, contributed significantly to the project – see below) were my research assistants in Sergipe. Both of them accompanied me on interviews, translated my awkward questions into more suave and acceptable Portuguese versions, and explained to me the subtleties of what my informants were telling me. Either of these undergraduates would have been superstars in an American research setting.

Rivanda Teixeira of the UFS business school was responsible for serving as my initial contact in Sergipe. She welcomed my cold-call emails and set up the original meetings that met research feasible in Aracaju. Ricardo Lacerda of the UFS economics department provided endless scholarly material on the Sergipana economy. I only had one interview with Vera França, the UFS geographer. Her work, however, is first rate and profoundly informed most of my views on Aracaju and on economic geography. Carlos Eduardo Traversa of SENAC-Sergipe was extraordinarily kind in providing the data on barber/beautician vocational trainees that provided the basis for much of the analysis on job training.

Ruth Dweck of the Economics Department of the Universidade Federal Fluminense was critical in arranging for my stay in Rio de Janeiro. Her work on the economics of the beauty business identified many of the critical issues that motivated my subsequent researches on this issue. Ruth

was a member of a key 1990s team from MITI that put Brazil in the forefront of the study of employment in services. The other members of that team, notably Alberto DiSabbato, Hildete Pereira de Melo and particularly Frederico Rocha, spent substantial time with me educating me on the dynamics of the service sector.

In Rio de Janeiro I also received critical support from the technical personnel at IBGE, the Brazilian Census agency. Roberto da Cruz Saldanha spent a great deal of time teaching me about the methodology of census collection on the service sector. Vania Prata was critical for arranging access to a key statistical dataset that provided the methodological insights that structured the rest of the econometric analysis.

In Cuiabá I received wonderful support from the economists and sociologists at the Universidade Federal de Mato Grosso. Wilson Oliveira was my primary contact at the university and an extraordinarily perceptive observer of the social dynamics of the Center-West. Carlos and Sueli Castro did everything to open up the resources of both their departments and made many critical introductions. João Carlos Barrozo is a remarkable expert on rural uprisings in Mato Grosso. His discussions of land tenure dynamics in Mato Grosso proved to be more relevant to the study of hotels and restaurants than I ever would have imagined.

The work on PRODETUR and airports was highly dependent on support from the staff at ETENE at the Banco do Nordeste in Fortaleza. Biágio de Oliveira Mendes Júnior was very generous in providing the full assistance of the research wing of the BNB. He not only arranged for interviews with both past and present staff, and provided a full range of access to documentary materials, but provided a significant amount of insight concerning the dynamics of development banking in the Northeast. Laura Friere and João Augustinho Teles were particularly informative and insightful about the dynamics of development projects at the bank.

In the United States, Edward Telles, (this time the Princeton professor), provided not only encouragement but practically a seminar's worth of information on the methodology of labor market analysis in Brazil. Gaye Seidman provided significant early insight and encouragement, although I think she would have wanted to see a quicker and more conflict-based manuscript. Bryan Roberts provided critical encouragement and advice, particularly at one very dark moment for the project. Zulema Valdez, Andrew Walder and Fred Block all read earlier versions of parts of the manuscript and told me true things I did not want to hear. Kirk Bowman of the political science department of Georgia Tech trained me in the basic history of international development banking and its engagement

with tourism. Hank Johnston and Ben Aguirre gave me basic and much needed training in how to do an interview (and even with their excellent advice, my undergraduate Brazilian assistants still had to correct my lack of good social skills in speaking to informants.)

I was helped by a large population of capable and talented undergraduate research assistants at Texas A and M. Matt Bradshaw, Elizabeth Rainwater, Jessica Schuett and David Watkins provided analyses of such quality that they merited co-authorship on the sections of the project they worked on. Kristin Miller provided key set-ups for the final year of analysis. Ariel Chisholm, Abbey Turner and Jennifer Borkowski were very important in the early and middle stages of the project.

I am particularly grateful to Nair Edwards, who taught me Portuguese. She also taught me the basics of Brazilian living and those aspects of the history of Mato Grosso do Sul that you cannot find in the history books. She continues to be one of the wisest women I have ever met.

Andrea Simao of CEDEPLAR and Ana Fereira of Campinas provided both hospitality and advice in the early stages of the project. Salvador Sandoval provided many conversations on Brazilian class conflict and Brazilian university dynamics that turned out to be relevant more often than I would have imagined.

The barbers and beauticians of Sergipe gave generously of their time to tell me their life stories and of the challenges they faced to their security and to their economic survival. Beatrice Caetana of EMBRATUR, Luiz Carlos da Silva Lima of Goiana, Ella Lazare, and Dilma of the Pousada dos Caminhos gave me eye-opening interviews that led me to change my thinking significantly on several issues.

Mike Curtis and Liz Gant Britton of the Soka Gakkai provided profound encouragement when the book ran into intractable obstacles in the writing stages.

And last, but certainly the most important of them all, is my wife Lynn Wallisch. She and my son followed me through Brazil on many occasions, and dealt with an absentee stressed husband for much of the time it took to bring this book to fruition. Her spiritual guidance, endless patience, and common-sense guidance for my methodological and fieldwork woes made her contribution to this work far greater than can be expressed here.
