Matt Cook instead takes 'queer indoors' and analyses queer home and family life. This book engages queer at home with histories of family, gender and home that have all but ignored the home and family life of queer men. This remarkable book problematises ideologies of home that dominated in England, and contextualises broader narratives in the period that regarded queer men's home and family life either as 'pretend', or non-existent. In common with all volumes in the *Genders and Sexualities in History* series, *Queer Domesticities: Homosexuality and Home Life in Twentieth-Century London* presents a multifaceted and meticulously researched scholarly study, and is a sophisticated contribution to our understanding of the past.
