# Notes on Contributors

**Ross Buck** is Professor of Communication and Psychology at the University of Connecticut. His research is concentrated on social development of motivation and emotion, and emotional communication as the basis of the social order. He is the author of *Human Motivation and Emotion* (1976, 1988, 2002), *The Communication of Emotion* (1984, 2000), and *Emotion: A Biosocial Synthesis* (2014). His research has engaged concepts such as social biofeedback fostering, emotional education and emotional competence, among others.

**Derek Chadee** is Professor of Social Psychology, Chair, Department of Behavioural Sciences and Director, ANSA McAL Psychological Research Centre, The University of the West Indies, St. Augustine Campus. His current research interests include the social psychology of fear of crime and general fear, antecedents of emotions, copy-cat behaviour, media, HIV, AIDS and jury decision making. He is also a Fulbright Scholar undertaking research on fear of crime in two American universities. He continues to maintain a cross-cultural research agenda.

**Tony Docan-Morgan** is Associate Professor in the Department of Communication Studies at the University of Wisconsin-La Crosse. **Jessica Harvey** is Assistant Professor in the Communication Department at Saint Vincent College. She acquired her Ph.D. from the University of Washington. Her research explores parent-child verbal and nonverbal communication as this relates to young people's media use. Her teaching focuses on children and media, mass media, media effects, research methods, and public relations.

**Arvid Kappas** is Professor of Psychology at Jacobs University, Bremen. Since obtaining his Ph.D. at Dartmouth College, NH, USA, Kappas has acquired international experience, having lived and worked in Switzerland, Canada, the UK, and in Germany, and visiting as Professor in Austria and Italy. His research examines the influence of factors such as social context and cognitive processes on the interaction of components of the emotion system, including what is felt, the expressions shown, and body reactions. **Eva Krumhuber** is an Assistant Professor at University College London, United Kingdom, and has been a member of the editorial board of the *Journal of Nonverbal Behavior* since 2010. Krumhuber's research focuses on the analysis and re-synthesis of facial expressions in human and artificial characters. She has also contributed to the design specifications of artificial systems and investigated processes that lead to the attribution and denial of human-like traits and emotions in humans and virtual agents, while working on the EU FP7-ICT project "eCUTE".

**Albert Mehrabian** is currently Professor Emeritus of Psychology at the University of California, Los Angeles. Mehrabian's experience with engineering and the natural sciences has supplied his psychological research with a distinctively scientific approach, which has contributed immensely to the development of various psychological tools as well as theoretical models aimed at measuring and describing complex psychological phenomena.

**Mike Miller** is an Assistant Professor in Residence of Communication at the University of Connecticut. His work, which centers on emotions, friendship, and physical touch, has been recently published in *Personal Relationships* and *Nonverbal Behavior*. While his main area of research concerns observable human communication, his efforts to explain innate, biological, and pan-cultural displays related to touch and nonverbal communication have also directed his research towards animal behavior and brain functioning.

**Milkica Nešić** is currently Full Professor of Physiology at the Department of Physiology, Medical Faculty, University of Niš. After acquiring her first degree in Medicine in 1979, Nešić acquired her Master's degree, looking at the role of interhemispheric asymmetry in discrimination of different tone qualities. She also specializes in Neuropsychiatry

and has been instrumental in the organization of courses related to neuroscience and the physiological basis of psychological processes, as well as behavioral and cognitive neuroscience, for both medicine and psychology students at the University of Niš. Nešić is a member of both the Serbian Association of Physiologists and the Serbian Association of Anthropologists, and has published over 100 scientific papers and handbooks in the field of neurophysiology and neuropsychology.

**Vladimir Nešić** is a Full Professor of Social Psychology, and member of EASP (European Association of Social Psychology), currently employed at the Department of Psychology, Faculty of Philosophy, University of Niš, where he took up tenure in 1973. An alumnus of both the University of Belgrade and the University of Niš, his diverse research interests have included the influence of job satisfaction on mental health, and individual differences in accuracy of person perception. He has also published over 100 scientific papers, and two books on the psychology of music. His work has led him to visit several Departments of Psychology in Germany.

**Fernando Poyatos** is an accomplished author and leading international scholar in the field of nonverbal communication. In 1993, he became the first Canadian citizen to be admitted to the prestigious Spanish Royal Academy of Language. He has also lectured extensively at universities throughout Europe, and has chaired and organized two international symposiums in Greece. During his 32-year tenure at the University of New Brunswick, Poyatos lectured in the departments of Spanish, anthropology, psychology and sociology, and also served as chairperson of the UNB department of Spanish and Latin American Cultures from 1992 until his retirement in June 1998.

**Marianne Schmid Mast** is a Professor of Psychology at the Department of Work and Organizational Psychology at the University of Neuchâtel, Switzerland and an Associate Editor of the *Journal of Nonverbal Behavior*. Through her use of immersive virtual environment technology, as well as computer-based automatic sensing and analyzing of nonverbal behavior in social interactions, her research investigates, inter alia, the effects of first impressions on interpersonal interaction, interpersonal sensitivity in the formation of impressions, interaction, communication and perception among persons in power hierarchies, the effects of physician communication on patient outcomes, and the effects of first impressions and nonverbal behavior in job interviews.
