ABOUT THE AUTHORS

Keith Breen is Senior Lecturer in Political and Social Theory at Queen's University, Belfast, Northern Ireland. His general research areas are contemporary political and social theory, the current focus of his research being questions of political ethics and philosophies of work and economic organization. His other research interests include theories of modernity and intersubjectivity, in particular the socio-political thought of Max Weber, Hannah Arendt, Jürgen Habermas, and Alasdair MacIntyre. He has published widely in peer-reviewed journals and is the author of *Under Weber's Shadow: Modernity, Subjectivity and Politics in Habermas, Arendt and MacIntyre* (2012). He is also co-editor of *After the Nation? Critical Reflections on Nationalism and Postnationalism* (2010) and of *Freedom and Domination: Exploring Republican Freedom* (2016).

Allyn Fives is Lecturer in Political Theory in the School of Political Science and Sociology at the National University of Ireland, Galway, Republic of Ireland. He is the author of *Political Reason: Morality and the Public Sphere* (2013) and *Political and Philosophical Debates in Welfare* (2008). His newest book, *on the topic of power and childhood*, is forthcoming with Manchester University Press in 2016. He has published in peer-reviewed journals in the areas of political reason, welfare theory, the political thought of Rawls and MacIntyre, and civic education. He is also affiliated with the UNESCO Child and Family Research Centre and has been involved in numerous social science studies. His social science publications have been in the areas of children's reading self-beliefs and the methodological and ethical questions raised by Randomized Controlled

Trials (RCTs). He teaches in the areas of political theory and research ethics and is Chair of the University's Research Ethics Committee.

John Foley is the author of *From the Absurd to Revolt: The Coherence of Camus' Philosophical Thought* (2008). He completed his PhD in Philosophy at the National University of Ireland, Galway, in 2002, and between 2004 and 2006 was the recipient of a post-doctoral fellowship from the Irish Research Council for the Humanities and Social Sciences. He has taught in Galway, Carbondale (Illinois), Aix-en-Provence, and London. He lives in London.

Richard Hull is Lecturer in Philosophy at the National University of Ireland, Galway, Republic of Ireland. He is the author of *Deprivation and Freedom* (2007) and of numerous peer-reviewed journal articles on freedom, disability, parental responsibility, and the doctrine of double effect. He is Director of the Centre of Bioethical Research and Analysis (COBRA), Ireland's first bioethics centre, established in 2001 as part of the Department of Philosophy, and is also a member of the National Advisory Committee on Bioethics. He teaches in the areas of bioethics, medical ethics, political theory, and applied philosophy.

Russell Keat is Emeritus Professor of Political Theory in the School of Social and Political Studies at the University of Edinburgh, Scotland. His research interests are in political theory and market economics, including issues about the boundaries between market and non-market spheres, consumer sovereignty and cultural goods, and the ethical implications of market institutions and varieties of capitalism. Publications in this area include *Cultural Goods and the Limits of the Market* (2000) and two collections co-edited with Nick Abercrombie and Nigel Whiteley, *Enterprise Culture* (1991) and *The Authority of the Consumer* (1994). Earlier research included work on the philosophy of the social sciences (*Social Theory as Science*, with John Urry, 1975/1982), Habermas's critical theory (*The Politics of Social Theory*, 1981), and phenomenology (*Understanding Phenomenology*, with Michael Hammond and Jane Howarth, 1991).

Alasdair MacIntyre is the Rev. John A. O'Brien Senior Research Professor of Philosophy at the University of Notre Dame, USA. He is also a senior research fellow at the Centre for Contemporary Aristotelian Studies in Ethics and Politics, London Metropolitan University. His major

publications include *Edith Stein: A Philosophical Prologue, 1913–22* (2006), two volumes of his selected essays, *The Tasks of Philosophy* and *Ethics and Politics* (2006), *Dependent Rational Animals* (1999), *Three Rival Versions of Moral Enquiry* (1990), *Whose Justice? Which Rationality?* (1988), *After Virtue* (1981), and *A Short History of Ethics* (1967). He has taught at a number of universities, including Oxford, Manchester, Essex, Princeton, Brandeis, Boston, Vanderbilt, Duke, and the University of Notre Dame.

James Edwin Mahon is Professor of Philosophy and Chair of the Department of Philosophy at CUNY-Lehman College, USA. He has taught at Washington and Lee University, Duke, and Yale. He was a visiting scholar in the Faculty of Philosophy at the University of Cambridge, a visiting fellow in the Department of Philosophy at Princeton University, and a visiting researcher at Yale Law School. His primary research interests are in moral philosophy, especially the nature and scope of moral duties, the history of moral philosophy, especially Kant, Mill, twentieth-century metaethics, and the intersection of law and applied ethics. He is the author of *Motivational Internalism and the Authority of Morality* (2011) and his essays have appeared in *What Happened in and to Moral Philosophy in the Twentieth Century?* (2013), *Contemporary Media Ethics* (2013), *The Philosophy of Deception* (2009), *Researching and Applying Metaphor* (1999), and *Metaphor and Rational Discourse* (1997). His articles have appeared in the *Encyclopedia of Lying and Deception*, *Stanford Encyclopedia of Philosophy*, *The Encyclopedia of Philosophy*, *The British Journal for the History of Philosophy*, *Kantian Review*, *Philosophy*, *The Journal of Value Inquiry*, *The International Journal of Applied Philosophy*, and *Studies in the History of Ethics*.

Joseph Mahon was Lecturer in Philosophy at the National University of Ireland, Galway, Republic of Ireland, from 1968 to 2013. His research and publications have concentrated on topics in Marxism, existentialism, feminism, applied ethics, and cultural policy. In addition to numerous journal articles, critical notices, and reviews, he has published three sole-authored books: *Simone de Beauvoir and Her Catholicism* (2002), *Existentialism, Feminism, and Simone de Beauvoir* (1997), and *An Introduction to Practical Ethics* (1984). His articles have appeared in *Journal of Moral Education*, *Understanding: A Journal of Ideas*, *Irish Medical Times*, *Philosophical Studies*, *History of European Ideas*, *Journal of*

Medical Ethics, *Philosophy in Review*, and *Politico*. He was also founding editor of *Understanding: A Journal of Ideas* (1972–75).

Felix Ó Murchadha is Professor of Philosophy at the National University of Ireland, Galway, Republic of Ireland. His areas of research include phenomenology (especially Heidegger, Merleau-Ponty, Ricoeur, Levinas, and Marion), philosophy of religion, and philosophy of time and of violence. He is the author of *A Phenomenology of Christian Life: Glory and Night* (2013), *The Time of Revolution: Kairos and Chronos in Heidegger* (2013), *Zeit des Handelns und Möglichkeit der Verwandlung: Kairologie und Chronologie bei Heidegger im Jahrzehnt nach ‘Sein und Zeit’* (1999), and editor of *Violence, Victims, Justifications: Philosophical Approaches* (2006). He has also published numerous journal articles and book chapters on his various research interests.

Annie McKeown O’Donovan is a researcher at the National University of Ireland, Galway, Republic of Ireland, with trans-disciplinary research interests in the broad area of applied philosophy. She has research experience from studying on MA in Philosophy: Ethics, Culture, and Global Change in the National University of Ireland, Galway, and on the MSc in Equality Studies at the School of Social Justice in University College Dublin. Her research in those programmes was primarily concerned with the influence of political philosophy on real world issues, such as mechanisms of transitional justice and solidarity in nationalism and the welfare state. Philip Pettit is Laurance S. Rockefeller University Professor of Politics and Human Values at Princeton University, USA, and the Distinguished Professor of Philosophy at the Australian National University, Canberra. He works in moral and political theory and on background issues in the philosophy of mind and metaphysics. His single-authored books include *The Robust Demands of the Good: Ethics with Attachment, Virtue, and Respect* (2015), *Just Freedom: A Moral Compass for a Complex World* (2014), *On the People’s Terms: A Republican Theory and Model of Democracy* (2012), *Made with Words: Hobbes on Language, Mind, and Politics* (2008), *Examen a Zapatero* (2008), *Penser en société* (2004), *Rules, Reasons, and Norms* (2002), *A Theory of Freedom* (2001), *Republicanism* (1997), and *The Common Mind* (1996). His co-authored books include *Group Agency* (with Christian List, 2011), *A Political Philosophy in Public Life: Civic*

Republicanism in Zapatero's Spain (with José Martí, 2010), *The Economy of Esteem* (with Geoffrey Brennan, 2004), and *Mind, Morality, and Explanation* (with Frank Jackson and Michael Smith, 2004). He gave the Tanner Lectures on Human Values at Berkeley in April 2015 under the title *The Birth of Ethics*, which is currently in preparation for publication.

Allen W. Wood is Professor of Philosophy at Indiana University, USA. He is the author of many articles and chapters in philosophical journals and anthologies. His book-length publications include *Immanuel Kant's Groundwork for the Metaphysics of Morals: A Commentary* (with Dieter Schönecker, 2015), *The Free Development of Each: Studies in Reason, Right, and Ethics in Classical German Philosophy* (2014), *Kantian Ethics* (2008), *Kant* (2004), *Unsettling Obligations* (2002), *Kant's Ethical Thought* (1999), *Hegel's Ethical Thought* (1990), *Karl Marx* (1981, second expanded edition 2004), *Kant's Rational Theology* (1978, reissued 2009), and *Kant's Moral Religion* (1970, reissued 2009). He is general editor (with Paul Guyer) of the *Cambridge Edition of Kant's Writings in English Translation*, for which he has edited, translated, or otherwise contributed to six volumes. Among the other books he has edited are *The Cambridge History of Philosophy in the Nineteenth Century (1790–1870)* (with Songsuk Susan Hahn, 2012), *Fichte: Attempt at a Critique of All Revelation* (2010), *Kant: Groundwork for the Metaphysics of Morals* (2002), *Hegel: Elements of the Philosophy of Right* (1991), and *Self and Nature in Kant's Philosophy* (1984). He is currently working on a book on Fichte's ethical thought.
