Technological change has transformed where people work, when and how. ## Notes on Contributors

**Elisabeth Angerer** is a work and organisational psychologist (MSc in Applied Psychology). **Premilla D’Cruz** is Professor of Organisational Behaviour at the Indian Institute of Management Ahmedabad, India. Premilla’s research interests include workplace bullying, emotions at work, self and identity, organisational control, and information and communications technologies (ICTs) and organisations.
