My first debt is to the [Canadian] Bureau of Municipal Research which in 1966 organised the establishment of forty multi-interest study groups in Metropolitan Areas of thirty countries, and especially to Simon R. Miles (then Assistant Director of the programme) who brought me in as Fiscal Consultant to the Study Seminar in Toronto in 1967. This assignment first drew my attention to the special problems of urban settlements as distinct from the general organisational and fiscal problems of local authorities in which I had long been interested.
