Saul Becker is Director of Studies for the interdisciplinary Master's degree programme in Policy, Organisation and Change in Professional Care in the Department of Social Sciences, Loughborough University. He teaches and writes on policy issues concerned with personal social services, social security and community care.

Trevor Bennett works at the Institute of Criminology, University of Cambridge, where he is a university lecturer. His academic interests include community policing, crime prevention, offending, and drug addiction.

Sue Conroy is a Research Officer at the Thomas Coram Research Unit in London. Her interests include child protection investigations and decision-making, and the joint investigation of child sexual abuse by the police and social services.
