Notes on the Contributors

Robert Ashton is Professor Emeritus and formerly Professor of English History, University of East Anglia. One of the leading historians of the Civil War period, his books include: *The Crown and the Money Market, 1603–1640* (1960), *The English Civil War: Conservatism and Revolution, 1603–1649* (1978 and 1989), *The City and the Court, 1603–1643* (1979) and *Counter-Revolution. The Second Civil War and its Origins, 1646–1648* (1994).

Ian Gentles is Associate Professor of History, Glendon College, York University, Toronto. He has written numerous articles on various aspects of the Civil War and the New Model Army, and *The New Model Army in England, Ireland and Scotland, 1645–1653* (1992).

Peter Kelsey is a chartered structural engineer whose principal field of activity is forensic work. His publications include a paper on the Civil War defences of London in *Veritas* (1991) and articles in journals related to the construction industry.

Lawson Nagel is a graduate of the University of Michigan, Ann Arbor. He was awarded a Ph.D. at King's College, University of London, in 1982 for his thesis on 'The Militia of London, 1641–1649'. After a career in publishing, he is now vicar of a parish near Chichester.

Stephen Porter is an Assistant Editor with the Survey of London, Royal Commission on the Historical Monuments of England. Author of a number of articles on urban history and the Civil War, his books include *A Gazetteer of English Urban Fire Disasters, 1500–1900* (1984, with E. L. Jones and M. Turner), *Exploring Urban History: Sources for Local Historians* (1990) and *Destruction in the English Civil Wars* (1994).

Keith Roberts graduated from the University of Leicester in 1977 and is now pursuing a career in banking. He is a military analyst

and lecturer on the theory and practice of war between 1600 and 1660. His published work includes *London and Liberty* (1987), *Barriffe, A Civil War Drill Book* (1988), *Soldiers of the English Civil War 1: Infantry* (1989, 1991 and 1992) and several articles on the development of English military theory and practice.

Ian Roy has recently retired from the Department of History, King's College, University of London. He has written a number of articles and edited texts concerning the English Civil War, including the *Royalist Ordnance Papers*, in two volumes (1964, 1973), and has contributed chapters on the city and the University of Oxford in the same period, part of an ongoing study of three provincial cities in the seventeenth century.

Victor Smith is an historian of artillery fortifications and has a special interest in the conservation of defence heritage sites. He has worked on the research and restoration of fortifications in Britain and abroad and has published extensively. He is currently Conservation Officer of the Fortress Study Group and is Director of the New Tavern Fort Project at Gravesend.

Rosemary Weinstein is curator of the sixteenth- and seventeenth-century collections in the Museum of London. She is currently researching a unique regimental set of royalist cavalry colours from the Civil War, acquired by the Museum. Her recent publications include *Tudor London* (1994), 'The Tyssens, Lords of the Manor of Hackney: From Strangers to English Landowners', in *The Strangers' Progress*, Huguenot Society Proceedings (1994), and 'Women Pewterers in London, 1500–1800' in a forthcoming collection of conference proceedings on women's studies.
