These proceedings contain the papers that were presented at the 8th International Conference on Language and Automata Theory and Applications (LATA 2014), held in Madrid, Spain, during March 10–14, 2014.

The scope of LATA is rather broad, including: algebraic language theory; algorithms for semi-structured data mining; algorithms on automata and words; automata and logic; automata for system analysis and program verification; automata, concurrency, and Petri nets; automatic structures; cellular automata; codes; combinatorics on words; compilers; computability; computational complexity; data and image compression; decidability issues on words and languages; descriptonal complexity; digital libraries and document engineering; DNA and other models of bio-inspired computing; foundations of finite state technology; foundations of XML; fuzzy and rough languages; grammars (Chomsky hierarchy, contextual, unification, categorial, etc.); grammatical inference and algorithmic learning; graphs and graph transformation; language varieties and semigroups; language-based cryptography; language-theoretic foundations of artificial intelligence and artificial life; natural language and speech automatic processing; parallel and regulated rewriting; parsing; patterns; power series; quantum, chemical and optical computing; semantics; string and combinatorial issues in computational biology and bioinformatics; string processing algorithms; symbolic dynamics; symbolic neural networks; term rewriting; transducers; trees, tree languages and tree automata; weighted automata.
