Notes on Contributors

Susannah Bannon is a doctoral candidate and Assistant Instructor of Communication Studies at The University of Texas at Austin. She received her M.A. in communication studies at Texas State University. Bannon's research is located at the intersection of rhetoric and social justice. Her current scholarship examines the ways in which public discourse creates and maintains social inequities and how rhetorical criticism can promote social justice.
